4 a party to participate in or offering a bonus or preferential treatment to a party  
5 participating in a project labor agreement; and generally relating to purchasing.

7 BY repealing: § 8-2-115(i)  
8 Anne Arundel County Code (2005, as amended)

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
11 That § 8-2-115(i) of the Anne Arundel County Code (2005, as amended) is hereby  
12 repealed.

14 SECTION 2. *And be it further enacted,* That Section(s) of the Anne Arundel County

6 from the date it becomes law.


