9 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
10 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

11 12 **ARTICLE 4. FINANCE, TAXATION, AND BUDGET**

13 14 **TITLE 7. SPECIAL COMMUNITY BENEFIT DISTRICTS, SHORE EROSION** 15 **CONTROL DISTRICTS, AND WATERWAYS IMPROVEMENTS DISTRICTS**

16 17 **4-7-204. Districts established.**

18 19 **(tt) Mil-Bur Special Community Benefit District.**

21 (2) The district is established for the purpose of acquiring, maintaining,
22 OPERATING, and improving all community real and personal property AND FACILITIES, and
23 defraying the administrative costs necessary to accomplish this purpose, including the
24 repayment of any loan, interest thereon, and any necessary insurance costs.

1 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days
