A BILL ENTITLED

1 AN ORDINANCE concerning: Current Expense Budget – Transfer of Appropriation –
2 Chief Administrative Office – Office of Central Services – Health Department

4 FOR the purpose of transferring an appropriation of funds from the Contingency Account
5 of the Chief Administrative Office to the Office of Central Services and the Health
6 Department; and generally relating to transferring appropriations of funds in the current
7 expense budget for the fiscal year ending June 30, 2019.

9 BY amending: Current Expense Budget

11 WHEREAS, under Section 711(a) of the Charter, the County Executive may
12 authorize transfers of funds within the same department and within the same fund;

15 WHEREAS, under Section 711(a) of the Charter, upon recommendation of the
16 County Executive, the County Council may transfer funds between offices,
17 departments, institutions, boards, commissions or other agencies of the County
18 government and within the same fund of the Current Expense Budget; and

20 WHEREAS, the County Executive has recommended the transfer of certain funds,
21 and the Controller has certified in writing that such funds are available for
22 appropriation; now, therefore,

1 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
2 That the Current Expense Budget for the fiscal year ending June 30, 2019, be and it is
