A BILL ENTITLED

1 AN ORDINANCE concerning: Zoning – Conditional Uses – Farm Breweries

2  
3 FOR the purpose of amending the conditional use requirements for farm breweries to  
4 require that a minimum of one acre of the farm be used to produce certain ingredients;  
5 and generally relating to zoning.

6  
7 BY repealing and reenacting, with amendments: § 18-10-111(1)  
8 Anne Arundel County Code (2005, as amended)

9  
10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
11 That Section of the Anne Arundel County Code (2005, as amended) reads as follows:

13 **ARTICLE 18. ZONING**

14  
15 **TITLE 10. REQUIREMENTS FOR CONDITIONAL USES**

16  
17 **18-10-111. Brewery, farm.**

18  
19 A farm brewery shall comply with all of the following requirements.

20  
21 (1) The facility shall be located on a farm of at least 10 acres, and the farm shall  
22 produce at least [25%] ONE ACRE of the grain, hops or other natural ingredients, excluding  
23 water, that is used to brew the beer.

25 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect 45 days  
26 from the date it becomes law.
