A BILL ENTITLED

1 AN ORDINANCE concerning: Current Expense Budget – Supplementary Appropriations
2 – Franklin Manor Shore Erosion Control District

4 FOR the purpose of making supplementary appropriations from unanticipated revenues to
5 the Franklin Manor Shore Erosion Control District for the fiscal year ending June 30,
6 2019.

8 BY amending: Current Expense Budget

10 WHEREAS a revised budget request has been submitted on behalf of the Franklin
11 Manor Shore Erosion Control District (“SECD”) to appropriate revenues that were
12 not appropriated for the fiscal year ending June 30, 2019; and

14 WHEREAS, these revenues were not anticipated in the Current Expense Budget;
15 and

16
17 WHEREAS, Section 712 of the Charter authorizes the County Council, upon the
18 recommendation of the County Executive, to make supplementary appropriations
19 from revenues received from sources not anticipated in the budget or from revenues
20 received from anticipated sources but in excess of budget estimates for the current
21 fiscal year, provided that the Controller shall first certify in writing that the funds
22 are available for appropriation; and

24 WHEREAS, the County Executive has recommended supplementary
25 appropriations, and the Controller has certified in writing that such funds are
26 available for appropriation; now, therefore,

1 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
2 That the Current Expense Budget for the fiscal year ending June 30, 2019, is hereby
3 amended by making supplementary appropriations from revenues received from sources
4 not anticipated in the budget to the Franklin Manor SECD in the amount of \$454,200.

5
6 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect from the
7 date it becomes law.
