1 RESOLUTION approving submission of names for the Property Tax Assessment
2 Appeal Board

4 WHEREAS, § 3-102 of the Tax-Property Article of the Annotated Code of
5 Maryland provides that there shall be a Property Tax Assessment Appeal Board in
6 Anne Arundel County; and

7
8 WHEREAS, § 3-103 of the Tax-Property Article of the Annotated Code of
9 Maryland provides that the Board members shall be appointed by the Governor
10 from a list of qualified applicants submitted by the County Executive with the
11 approval of the County Council; and

13 WHEREAS, the Board consists of three regular members and three alternate
14 members, each serving a term of 5 years beginning on June 1 of the year of
15 appointment; and

17 WHEREAS, a vacancy exists for Jeffrey L. Jefferson, a regular member, whose
18 term expired on June 1, 2018; and

20 WHEREAS, a vacancy exists for Raymond F. Frederick, an alternate member,
21 whose term expired on June 1, 2018; and

23 WHEREAS, § 3-103 of the Tax-Property Article provides that a list of three names
24 for each vacancy shall be submitted to the Governor; and

26 WHEREAS, the County Executive, subject to the approval of the County Council,
27 has submitted the names of the following individuals to fill the vacancy for the
28 regular member: Jeffrey L. Jefferson, incumbent, Brian J. Metzbower, and Maria
29 Luna Baker; and

31 WHEREAS, the County Executive, subject to the approval of the County Council,
32 has submitted the names of the following individuals to fill the vacancy for the
33 alternate member: Raymond F. Frederick, incumbent, John W. Adkins, and Rocco
34 A. Ferretti; now, therefore, be it

36 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*
37 *approves the submittal of the names of the following individuals to the Governor as*
38 *qualified applicants to be a regular member of the Property Tax Assessment Appeal Board*

1 to serve the term ending June 1, 2023: Jeffrey L. Jefferson, incumbent, Brian J. Metzbower,
2 and Maria Luna Baker; and be it further

4 *Resolved*, That it hereby approves the submittal of the names of the following
5 individuals to the Governor as qualified applicants to be an alternate member of the
6 Property Tax Assessment Appeal Board to serve the remainder of a term ending June 1,
7 2023: Raymond F. Frederick, incumbent, John W. Adkins, and Rocco A. Ferretti; and be


