1	RESOLUTION approving the application to establish a BRAC Revitalization and
2	Incentive Zone within the boundaries of Odenton Town Center

4	WHEREAS, the Base Realignment and Closure ("BRAC") Community
5	Enhancement Act (Economic Development Article, Title 5, Subtitle 13, of the State
6	Code) creates funding to finance public infrastructure to support development and
7	redevelopment in designated Priority Funding Areas; and

9	WHEREAS, Odenton Town Center is located adjacent to Fort George G. Meade,
10	consists of 1,600 acres and seven sub-areas of mixed-use zoning, and is located
11	within a Priority Funding Area as determined by the Maryland Department of
12	Planning; and

14	WHEREAS, Anne Arundel County is making application to the Maryland
15	Department of Commerce to establish a BRAC Revitalization and Incentive Zone
16	("BRAC Zone") within the boundaries of the Odenton Town Center; and
17	WHIEDEAC the DDAC Zone would be the besis for Anna Amadel County to
18	WHEREAS, the BRAC Zone would be the basis for Anne Arundel County to receive State funding based on incremental assessments generated by new
19	investment in residential, commercial, and industrial real property in the BRAC
20 21	Zone; and

23	WHEREAS, all funds received by the County under the provisions of the BRAC
24	Zone designation will be applied to infrastructure improvements deemed necessary
25	for the full development and redevelopment of the Odenton Town Center; and

27	WHEREAS, the County previously applied for BRAC Zone designation for the
28	Odenton Town Center in 2008, which was granted in 2009, and will expire on April
29	15, 2019; and

31	WHEREAS, the BRAC Zone Application must be submitted with a supporting
32	Resolution from the County Council; now, therefore, be it

Resolved by the County Council of Anne Arundel County, Maryland, That the County

Council hereby endorses and supports the establishment of a BRAC Revitalization and

Incentive Zone for Odenton Town Center and hereby approves the submittal of the

application for the BRAC Zone designation to the Maryland Department of Commerce;
