1 RESOLUTION confirming appointments of Anne Arundel County residents to serve  
2 on the Spending Affordability Committee

3  
4 WHEREAS, Section 610(a) of the Charter of Anne Arundel County, Maryland,  
5 provides that there is a Spending Affordability Committee that is appointed by the  
6 County Executive and confirmed by resolution of the County Council; and

7  
8 WHEREAS, Section 610(c) of the Charter provides that the Spending Affordability  
9 Committee shall consist of one resident from each councilmanic district who is  
10 knowledgeable in the field of economics, finance, fiscal planning, or a related field;  
11 and

13 WHEREAS, Section 610(d) of the Charter provides that each member of the  
14 Spending Affordability Committee shall be appointed for a term of four years not  
15 to exceed two successive terms; and

16  
17 WHEREAS, the term of the member from District 3 expired on December 1, 2017;  
18 the terms of the members from Districts 1, 5, and 6, expired on December 1, 2018;  
19 and the term of the member for District 4 is set to expire on December 1, 2020, but  
20 the position is currently vacant; and

22 WHEREAS, the County Executive, subject to confirmation by the County Council,  
23 has appointed Deborah T. Ritchie, a resident of District 3, to serve on the Spending  
24 Affordability Committee for the remainder of ending on December 1, 2021; Nicole  
25 V. Butler, a resident of District 1, Mary Clapsaddle, a resident of District 5, and Dr.  
26 David B. Juppe, a resident of District 6, to serve on the Spending Affordability  
27 Committee for the remainder of terms ending on December 1, 2022; and Donny R.  
28 James, a resident of District 4, to serve on the Spending Affordability Committee  
29 for the remainder of a term ending on December 1, 2020; and

31 WHEREAS, the County Council, after public hearing, finds that, Deborah T.  
32 Ritchie, Nicole V. Butler, Mary Clapsaddle, Dr. David B. Juppe, and Donny R.  
33 James meet the eligibility requirements under Section 610 of the Charter to serve  
34 on the Spending Affordability Committee; now, therefore, be it

36 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*  
37 *approves the appointments of Deborah T. Ritchie, a resident of District 3, to serve on the*  
38 *Spending Affordability Committee for a remainder of a term ending on December 1, 2021;*

1 Nicole V. Butler, a resident of District 1, Mary Clapsaddle, a resident of District 5, and Dr.  
2 David B. Juppe, a resident of District 6, to serve on the Spending Affordability Committee  
3 for the remainder of terms ending on December 1, 2022; and Donny R. James, a resident  
4 of District 4, to serve on the Spending Affordability Committee for the remainder of a term  
5 ending on December 1, 2020; and be it further

8 Chief Administrative Officer Benjamin J. Birge; Deborah T. Ritchie, Nicole V. Butler,
