A BILL ENTITLED

1 AN ORDINANCE concerning: Capital Budget and Program – Athletic Stadium
2 Improvements – Additional Appropriation – School Security Upgrades – Fund Transfer
3 – School Construction Fund
4

5 FOR the purpose of amending the Capital Budget by making an additional appropriation
6 to the School Construction Fund, Athletic Stadium Improvements capital project;
7 amending the capital budget by transferring funds from the School Security Upgrades
8 capital project (General County Class) to the Security Related Upgrades capital project
9 (Board of Education Class); and amending the Capital Program and Capital Projects
10 Bond Ordinance.

12 BY amending: Capital Budget

16 WHEREAS, the Athletic Stadium Improvements capital project, Project No.
17 E549300, has an existing appropriation in the Capital Budget for the fiscal year
18 ending June 30, 2019, and additional funding has become available from the State
19 of Maryland in excess of budget estimates for the current fiscal year; and
20

21 WHEREAS, Sections 712 and 716 of the Charter authorize the County Council,
22 upon request of the County Executive and by the affirmative vote of five members
23 of the County Council, to amend the capital budget and to increase the total amount
24 of appropriations to the capital budget from revenues received from anticipated
25 sources in excess of budget estimates for the current fiscal year; and

1 WHEREAS, § 5-107(b)(1) of the Education Article of the Annotated Code of
2 Maryland requires that expenditures for school building construction be made in
3 accordance with the cost approved by the County Council for each project; and
4

5 WHEREAS, Section 711(b) of the Charter authorizes the County Council, upon
6 request of the County Executive, to transfer appropriations between capital projects
7 in the Capital Budget; and
8

9 WHEREAS, the Board of Education and the County Executive have requested the
10 additional appropriation and transfer of funds; and
11

12 WHEREAS, in accordance with Section 716 of the Charter, the Planning Advisory
13 Board has recommended amendments to the Capital Budget; and
14

15 WHEREAS, the Controller has certified in writing that the funds are available for
16 appropriation; now, therefore,
17

18 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
19 That the Capital Budget for the fiscal year ending June 30, 2019, is hereby amended by
20 making an additional appropriation in the amount of \$3,000,000 from the State of
21 Maryland, which is in excess of budget estimates for the current fiscal year, to the School
22 Construction Fund, Athletic Stadium Improvements capital project, Project No. E549300.
23

24 SECTION 2. *And be it further enacted,* That the Capital Budget for the fiscal year
25 ending June 30, 2019, is hereby amended by transferring funds in the amount of \$5,000,000
26 from the School Security Upgrades capital project (General County Class), Project No.
27 C574700, to the Security Related Upgrades capital project (Board of Education Class),
28 Project No. E538100.
29

30 SECTION 3. *And be it further enacted,* That the Capital Program and Capital Projects
31 Bond Ordinance are hereby amended in accordance with the provisions of this Ordinance.

33 SECTION 4. *And be it further enacted,* That this ordinance shall take effect from the
34 date it becomes law.




