4	WHEREAS, Paragon Bioservices, Inc. applied for a loan by the Maryland
5	Department of Business and Economic Development from the Maryland
6	Economic Development Assistance Authority and Fund ("MEDAAF") in the
7	amount of \$600,000 (the "Financial Assistance"); and

9	WHEREAS, the Financial Assistance was endorsed by the County Executive and
10	by the County Council in Resolution No. 14-18; and
11	WHIRDEAC the amount of the Firewaist Assistance has been in
12	WHEREAS, the amount of the Financial Assistance has been increased to \$1,300,000; and

15	WHEREAS, the Financial Assistance is being used by Paragon Bioservices, Inc.
16	to expand its headquarters and manufacturing operations into the County; and
17	to expand its neadquarters and mandrasturing operations into the county, and
18	WHEREAS, in accordance with § 5-319(d)(1) of the Economic Development
19	Article of the State Code, the governing body of the jurisdiction in which a project
20	is located must endorse the Financial Assistance to be provided from MEDAAF
21	by formal resolution; and

23	WHEREAS, the County Executive endorses the Financial Assistance; now,
