1 RESOLUTION approving the reappointment of Brian E. Riddle as a supervisor of the
2 Anne Arundel Soil Conservation District

4 WHEREAS, § 8-302(a) of the Agriculture Article of the Annotated Code of
5 Maryland provides that the governing body of each soil conservation district
6 consists of five supervisors; and

8 WHEREAS, § 8-302(c)(1) of the Agriculture Article of the Annotated Code of
9 Maryland provides that one of the supervisors shall be a resident of the district
10 serving at the pleasure of the county governing body; and

11
12 WHEREAS § 8-302(c)(1) further provides that the appointment shall be made by
13 the County Executive and approved by the County Council; and

14
15 WHEREAS, § 8-302(d) of the Agriculture Article of the Annotated Code of
16 Maryland provides that each supervisor shall hold office until his successor is
17 appointed and qualifies; and

19 WHEREAS, Brian E. Riddle, a supervisor of the Anne Arundel Soil Conservation
20 District, was appointed by the County governing body to serve the remainder of a
21 term which expired on March 31, 2019; and

23 WHEREAS, the County Executive has appointed Brian E. Riddle, a resident of the
24 Anne Arundel Soil Conservation District, as a Supervisor of the Anne Arundel Soil
25 Conservation District to serve a term expiring on March 31, 2024, subject to
26 approval by the County Council; and

28 WHEREAS, the County Council, after public hearing, finds that Brian E. Riddle
29 meets the eligibility requirements under § 8-302 of the Agriculture Article of the
30 Annotated Code of Maryland and is qualified to serve as a supervisor of the Anne
31 Arundel Soil Conservation District; now, therefore, be it

33 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*
34 *approves the appointment of Brian E. Riddle, a resident of the district, as a Supervisor of*
35 *the Anne Arundel Soil Conservation District for a term that expires on March 31, 2024;*
36 *and be it further*
