5	River Commission in Resolution No. 130-84, and reestablished the Commission
6	in Resolution No. 47-89; and

8	WHEREAS, Resolution No. 47-89 provides that, subject to confirmation by the
9	County Council, the County Executive shall appoint seven voting members to the
10	Severn River Commission, at least five of whom are residents of the Severn River
11	Watershed; and

13	WHEREAS, Resolution No. 47-89 further provides that each member of the
14	Severn River Commission shall serve a term of three years from the date of
15	appointment; and
16	WHEDEAC the terms of Charles D. Vreter Core C. Dhilling and Arthur A
17	WHEREAS, the terms of Charles R. Kreter, Sara G. Phillips, and Arthur A. Birney, Jr., members of the Severn River Commission who are residents of the

21	WHEREAS, the term of Daniel J. Roche, a member of the Severn River
22	Commission who is not a resident of the Severn River Watershed, expired on

26	Phillips, and Arthur A. Birney, Jr. to serve on the Severn River Commission for
27	terms beginning on February 1, 2018, and ending on January 31, 2021; and Daniel
28	J. Roche to serve on the Severn River Commission for a term beginning February
29	1, 2017, and ending on January 31, 2020; and

31	WHEREAS, the County Council, after a public hearing, finds that Charles R.
32	Kreter, Sara G. Phillips, Arthur A. Birney, Jr., and Daniel J. Roche meet the
33	eligibility requirements under Resolution No. 47-89, and are qualified to serve on
34	the Severn River Commission; now, therefore, be it
