9	forwards the name of a nominee for the position of Health Officer to the County
10	Council, and, if the County Council approves, the name of the nominee is
11	forwarded to the Secretary; and
12	WHERE AC there is no purced and in Ctate love for consistences of an action H14.
13	WHEREAS, there is no procedure in State law for appointment of an acting Health
14 15	Officer, but the Secretary has agreed that the Secretary may appoint an acting Health Officer on the recommendation of the County; and
16	riearth Officer on the recommendation of the County, and
17	WHEREAS, upon recommendation of former County Executive Steven R. Schuh
18	and approval of that recommendation by the County Council through adoption of
19	Resolution No. 37-18, and upon recommendation of County Executive Steuart

21	adoption of Resolution No. 9-19, the Secretary has appointed Billie Penley as
22	Acting Health Officer since August 29, 2018; and

24	WHEREAS, the County Executive is recommending that Billie Penley continue to
25	serve as Acting Health Officer from June 2, 2019, through October 1, 2019, or
26	until a Health Officer is appointed by the Secretary, whichever occurs first; and
