1 RESOLUTION reappointing members to the Anne Arundel County Adult Public
2 Guardianship Review Board

4 WHEREAS, § 14-402(a)(1) of the Family Law Article of the State Code requires
5 that the Anne Arundel County Adult Public Guardianship Review Board consists
6 of 11 members appointed by the County Executive with the advice and consent of
7 the County Council; and

9 WHEREAS, § 14-402(a)(2) of the Family Law Article of the State Code requires
10 that, of the 11 members, one shall be a professional representative of a local
11 department of social services, one shall be a physician's assistant, nurse
12 practitioner, or physician who is not a psychiatrist, one shall be a psychiatrist, one
13 shall be a representative of a local commission on aging, one shall be a professional
14 representative of a local nonprofit social service organization, one shall be a lawyer,
15 two shall be lay individuals, one shall be a registered nurse, one shall be a
16 professional in the field of disabilities, and one shall be a person with a physical
17 disability; and

19 WHEREAS, § 14-402(b) of the Family Law Article of the State Code provides that
20 the term of a member is three years, that, at the end of a term, a member continues
21 to serve until a successor is appointed and qualifies, and that a member who is
22 appointed after a term has begun serves only for the rest of the term and until a
23 successor is appointed and qualifies; and

25 WHEREAS, the County Executive, subject to the advice and consent of the County
26 Council, has reappointed Carol Allison, a professional representative of a local
27 department of social services, and Julie Provan, a professional in the field of
28 disabilities, to serve on the Anne Arundel County Adult Public Guardianship
29 Review Board for terms expiring on July 7, 2025; and

31 WHEREAS, the County Council, after public hearing, finds that Carol Allison and
32 Julie Provan meet the eligibility requirements under § 14-402 of the Family Law
33 Article of the State Code and are qualified to serve on the Anne Arundel County
34 Adult Public Guardianship Review Board; now, therefore, be it

36 *Resolved by the County Council of Anne Arundel County, Maryland,* That it hereby
37 approves the reappointment of Carol Allison, a professional representative of a local
38 department of social services, and Julie Provan, a professional in the field of disabilities,

1 to serve as members of the Anne Arundel County Adult Public Guardianship Review Board
2 for terms expiring on July 7, 2025; and be it further
