1	RESOLUTION approving the declaration of certain unimproved non-buildable
2	County-owned property on Veteran's Highway in Millersville, Maryland as surplus
3	property

5	WHEREAS, § 8-3-202 of the Anne Arundel County Code (2005, as amended)
6	authorizes the County Executive to dispose of real property owned by the County
7	when the County Executive, with the approval of the County Council, has
8	determined that the real property is surplus property; and

10	WHEREAS, the County Executive has determined that the property described
11	below ("the Property") is surplus property and wishes to dispose of it in
12	accordance with Article 8, Title 3, Subtitle 2 of the County Code; and

14	WHEREAS, the County Council, after a public hearing on this Resolution, finds
15	that the public interest will be furthered by declaring the Property to be surplus
16	property; now, therefore, be it
17	
18	WHEREAS, § 8-3-208 of the Anne Arundel County Code (2005, as amended)
19	(and as amended by Bill 79-16) authorizes the County to dispose of County-
20	owned property by private disposition if the property is declared by the Planning
21	and Zoning Officer to be non-buildable, is less than one-tenth of an acre in size,
22	and is determined by the Central Services Officer to be surplus property, and if
23	said determination is approved by the Chief Administrative Officer and by
24	resolution of the County Council; and

26	WHEREAS, the Planning and Zoning Officer has declared that certain County-
27	owned property located on Veteran's Highway in Millersville, Maryland, as
28	described herein (the "Property"), is non-buildable, the Central Services Officer
29	has determined that the Property is surplus, and the Chief Administrative Officer
30	has approved the Central Services Officer's determination; and
31	WHEREAG A
32	WHEREAS, after a public hearing on this Resolution, the County Council
33	approves the Central Services Officer's determination that the Property is surplus;
34	now, therefore, be it

Resolved by the County Council of Anne Arundel County, Maryland, That in accordance with § 8-3-202 § 8-3-208 of the County Code, it hereby approves the County Executive's determination that the property on Veteran's Highway, Millersville, Maryland, located in the Fifth Councilmanic District, containing 1,881 square feet of land, more or less, is surplus property, being more fully described as:

PARCEL THREE

BEGINNING for the same at an iron pipe set in the southwest corner of Lot "B", as shown on a map of a survey by August H. Wagener, Licensed Surveyor, dated February 23, 1955, said pipe being on the east side of Crain Highway and located North 09 degrees 00 minutes 40 seconds West, 242.03 feet from the northwest corner of a lot as described in Liber J.H.H. No. 381, folio 476, and recorded among the Land Records of Anne Arundel County, on the Crain Highway, thence along the east side of Crain Highway North 09 degrees 00 minutes 40 seconds West, 100 00 feet to a pipe set; thence leaving said Crain Highway, North 80 degrees 59 minutes 20 seconds East 200.00 feet to a pipe set; thence South 09 degrees 00 minutes 40 seconds East, 100 00 feet to a pipe found, thence South 80 degrees 59 minutes 20 seconds West, 200.00 feet to the point of beginning. Containing in all 0.459 acres of land, more or less.

SAVING AND EXCEPTING THEREFROM so much of the property which was conveyed to the State Roads Commission of Maryland, by deed dated October 15, 1956, and recorded among the Land Records of Anne Arundel County in Liber G.T.C. No. 1070, folio 348, and

SAVING AND EXCEPTING THEREFROM so much of the property which was conveyed to the State Highway Administration of the Department of Transportation by deed dated December 6, 1986 and recorded among the Land Records of Anne Arundel County in Liber 4244, folio 392; as shown on Right of Way Plat No. 49075 and recorded among the Land Records of Anne Arundel County in State Road Plat Book on December 16, 1987.

BEING the same lot of land described as "PARCEL THREE" which was conveyed by Marion Matuszewski and Bernadette J. Dombroski to Anne Arundel County, Maryland, a body corporate and politic of the State of Maryland, in fee simple, by deed dated September 22, 1997 and recorded among the Land Records of Anne Arundel County in Book 8078, Page 239 on September 24, 1997.
