1 RESOLUTION appointing a member to the Anne Arundel County Adult Public  
2 Guardianship Review Board

3  
4 WHEREAS, the Family Law Article, § 14-402, of the State Code requires that the  
5 Anne Arundel County Adult Public Guardianship Review Board consist of 11  
6 members appointed by the County Executive with the advice and consent of the  
7 County Council; and

8  
9 WHEREAS, the Family Law Article, § 14-402(a)(2), of the State Code requires  
10 that, of the 11 members, one shall be a professional representative of a local  
11 department of social services; one shall be a physician's assistant, nurse  
12 practitioner, or physician who is not a psychiatrist; one shall be a psychiatrist; one  
13 shall be a representative of a local commission on aging; one shall be a  
14 professional representative of a local nonprofit social service organization; one  
15 shall be a lawyer; two shall be lay individuals; one shall be a registered nurse; one  
16 shall be a professional in the field of disabilities; and one shall be a person with a  
17 physical disability; and

19 WHEREAS, the Family Law Article, § 14-402(b), of the State Code provides that  
20 the term of a member is three years, that at the end of a term, a member continues  
21 to serve until a successor is appointed and qualifies, and that a member who is  
22 appointed after a term has begun serves only for the rest of the term and until a  
23 successor is appointed and qualifies; and

25 WHEREAS, the term of the lawyer member expired June 30, 2017; and

27 WHEREAS, the County Executive, subject to the advice and consent of the  
28 County Council, has appointed Kimberly C. Aviles, a lawyer, to a term expiring  
29 June 30, 2020; and

31 WHEREAS, the County Council, after public hearing, finds that Kimberly C.  
32 Aviles meets the eligibility requirements under the Family Law Article, § 14-402,  
33 of the State Code and is qualified to serve on the Anne Arundel County Adult  
34 Public Guardianship Review Board; now, therefore, be it

36 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*  
37 *approves the appointment of Kimberly C. Aviles to a term expiring June 30, 2020; and be*  
38 *it further*

1        *Resolved*, That a copy of this Resolution be sent to County Executive Steven R.  
2        Schuh; appointee Kimberly C. Aviles, Esquire; and Arlene Berlin, Director of Boards and  
3        Commissions.


