RESOLUTION appointing a member to the Anne Arundel County Adult Public 1 2 Guardianship Review Board 3 4 WHEREAS, the Family Law Article, § 14-402, of the State Code requires that the Anne Arundel County Adult Public Guardianship Review Board consist of 11 5 members appointed by the County Executive with the advice and consent of the 6 7 County Council; and 8 9 WHEREAS, the Family Law Article, § 14-402(a)(2), of the State Code requires that, of the 11 members, one shall be a professional representative of a local 10 department of social services; one shall be a physician's assistant, nurse 11 practitioner, or physician who is not a psychiatrist; one shall be a psychiatrist; one 12 shall be a representative of a local commission on aging; one shall be a 13 professional representative of a local nonprofit social service organization; one 14 shall be a lawyer; two shall be lay individuals; one shall be a registered nurse; one 15 shall be a professional in the field of disabilities; and one shall be a person with a 16 physical disability; and 17 18 19 WHEREAS, the Family Law Article, § 14-402(b), of the State Code provides that the term of a member is three years, that at the end of a term, a member continues 20 to serve until a successor is appointed and qualifies, and that a member who is 21 appointed after a term has begun serves only for the rest of the term and until a 22 successor is appointed and qualifies; and 23 24 25 WHEREAS, the term of the lawyer member expired June 30, 2017; and 26 27 WHEREAS, the County Executive, subject to the advice and consent of the 28 County Council, has appointed Kimberly C. Aviles, a lawyer, to a term expiring June 30, 2020; and 29 30
