20	WHEREAS, an alternate member, serving a term expiring on June 1, 2018, has
21	resigned from the Board; and

23	WHEREAS, § 3-103 provides that a list of three names for each vacancy shall be
24	submitted to the Governor; and

26	WHEREAS, the names of the following individuals have been submitted by the
27	County Executive for approval to fill the vacancy for the regular member: Owen
28	McDonnell Taylor, Maria Luna Baker, and Carol Sures; and

30	WHEREAS, the names of the following individuals have been submitted by the
31	County Executive for approval to fill the vacancy for the alternate member: Jan
32	Holland, Richard B. Ladd, and Raymond Frederick; now, therefore, be it

34	Resolved by the County Council of Anne Arundel County, Maryland, That it hereby
35	approves the submittal of the names of the following individuals to the Governor as
36	qualified applicants to be a regular member of the Property Tax Assessment Appeal
37	Board to serve the term ending June 1, 2022: Owen McDonnell Taylor, Maria Luna
