WHEREAS, Scott L. Shifflett and Mary K. Shifflett have made application (the "Shifflett Application") to the Maryland Agricultural Land Preservation Foundation (the "Foundation") to sell an agricultural land preservation easement on real property described in a deed dated August 23, 1983, and recorded in the land records of Anne Arundel County in Book 3633, Page 146, consisting of 116.27 acres, more or less, located in Tracys Landing, Anne Arundel County, Maryland, and shown generally on Exhibit 1, attached to this Resolution and made a part

hereof (the "Shifflett Property"); and

WHEREAS, pursuant to Title 2, Subtitle 5 of the Agriculture Article of the State Code and regulations adopted pursuant thereto, the County governing body is required to advise the Foundation as to a local recommendation of approval or disapproval of the Shifflett Application; and

WHEREAS, in deciding whether to approve the Shifflett Application, the County governing body is to receive the recommendation of the Office of Planning and Zoning and the County Agricultural Preservation Advisory Board (the "Board") based on criteria and standards identified in Title 2, Subtitle 5 of the Agriculture Article of the State Code and regulations adopted pursuant thereto; and

WHEREAS, the Office of Planning and Zoning, the Board, and the County Executive have recommended approval of the Shifflett Application; and

WHEREAS, the County Council finds that approval of the Shifflett Application is in the best interest of the citizens of Anne Arundel County; now, therefore, be it

Resolved by the County Council of Anne Arundel County, Maryland, That it hereby approves the recommendation of approval of the Shifflett Application to sell an agricultural land preservation easement on the Shifflett Property to the Foundation; and be it further

Resolved, That a copy of this Resolution be sent to Steuart Pittman, County Executive; Scott L. Shifflett; Mary K. Shifflett; and the Maryland Agricultural Land Preservation Foundation.
