1 RESOLUTION appointing a member to the Anne Arundel County Ethics Commission

3 WHEREAS, Section 1001 of the Charter establishes the Anne Arundel County
4 Ethics Commission, whose members are appointed by the County Executive with
5 the approval of the County Council; and

7 WHEREAS, the Ethics Commission has seven members, of which no more than
8 four shall be members of the same political party; and

9

10 WHEREAS, Section 1001 of the Charter provides that three of the seven members
11 shall be nominated by the County Council; and

12

13 WHEREAS, the term of Vanessa Carter (Democrat), one of the current members
14 of the Ethics Commission nominated by the County Council and appointed by the
15 County Executive, expires on April 30, 2019; and

17 WHEREAS, by Resolution No. 5-19, the County Council nominated Vanessa
18 Carter (Democrat) for reappointment to the Ethics Commission to serve a second
19 term expiring on April 30, 2023; and

21 WHEREAS, the County Executive, subject to the approval of the County Council,
22 has reappointed Vanessa Carter (Democrat) to serve a second term expiring on
23 April 30, 2023; and

25 WHEREAS, the County Council, after public hearing, has found Vanessa Carter
26 (Democrat) to be qualified under Section 1001 of the Charter to serve a second term
27 on the Ethics Commission; now, therefore, be it

29 *Resolved by the County Council of Anne Arundel County, Maryland,* That it hereby
30 approves the reappointment of Vanessa Carter (Democrat) to the Anne Arundel County
31 Ethics Commission to serve a second term expiring on April 30, 2023; and be it further

33 *Resolved,* That a copy of this Resolution be sent to County Executive Steuart Pittman;
34 Vanessa Carter, appointee; Michael S. Botsaris, Director, Anne Arundel County Ethics
35 Commission; and Janice Hayes-Williams, Director of Minority Engagement and
36 Advancement.
