1 RESOLUTION approving the appointments of members to the Severn River
2 Commission

4 WHEREAS, the County Council of Anne Arundel County established the Severn
5 River Commission in Resolution No. 130-84, and reestablished the Commission in
6 Resolution No. 47-89; and

8 WHEREAS, Resolution No. 47-89 provides that, subject to confirmation by the
9 County Council, the County Executive shall appoint seven voting members to the
10 Severn River Commission, at least five of whom are residents of the Severn River
11 Watershed; and

13 WHEREAS, Resolution No. 47-89 further provides that each member of the Severn
14 River Commission shall serve a term of three years from the date of appointment;
15 and

17 WHEREAS, the term of William J. Kardash, a member of the Severn River
18 Commission who is a resident of the Severn River Watershed, expired January 31,
19 2019, and the term of Robert Whitcomb, a member of the Severn River
20 Commission who is a resident of the Severn River Watershed, expired January 31,
21 2020; and

23 WHEREAS, the term of Daniel J. Roche, a member of the Severn River
24 Commission who is not a resident of the Severn River Watershed, expired on
25 January 31, 2020; and

27 WHEREAS, the County Executive has appointed Clinton Lee Meadows, who is a
28 resident of the Severn River Watershed, to serve on the Severn River Commission
29 for the remainder of a term ending on January 31, 2022; and Lynne Dowling-
30 Rockenbauch, who is a resident of the Severn River Watershed, and Keith Hansen,
31 who is not a resident of the Severn River Watershed, to serve on the Severn River
32 Commission for terms beginning February 1, 2020 and ending on January 31, 2023;

35 WHEREAS, the County Council, after a public hearing, finds that Clinton Lee
36 Meadows, Lynne Dowling-Rockenbauch, and Keith Hansen meet the eligibility
37 requirements under Resolution No. 47-89, and are qualified to serve on the Severn
38 River Commission; now, therefore, be it

1 *Resolved by the County Council of Anne Arundel County, Maryland,* That it confirms
2 the appointment of Clinton Lee Meadows, who is a resident of the Severn River Watershed,
3 to serve on the Severn River Commission for the remainder of a term ending on January
4 31, 2022; and Lynne Dowling-Rockenbauch, who is a resident of the Severn River
5 Watershed, to serve on the Severn River Commission for a term beginning February 1,
6 2020 and ending on January 31, 2023; and Keith Hansen, who is not a resident of the
7 Severn River Watershed, to serve on the Severn River Commission for a term beginning
8 February 1, 2020 and ending on January 31, 2023; and be it further

10 *Resolved,* That copies of this Resolution be sent to County Executive Steuart Pittman;
11 Jim Burdick, Chair and appointees of the Severn River Commission; Lynne Dowling-
12 Rockenbauch, Keith Hansen, and Clinton Lee Meadows; and Kaley Schultze, Coordinator
13 of Boards and Commissions.
