1 RESOLUTION confirming the appointment of an Anne Arundel County resident to
2 serve on the Spending Affordability Committee

4 WHEREAS, Section 610(a) of the Charter of Anne Arundel County, Maryland,
5 provides that there is a Spending Affordability Committee that is appointed by the
6 County Executive and confirmed by resolution of the County Council; and

8 WHEREAS, Section 610(c) of the Charter provides that the Spending
9 Affordability Committee shall consist of one resident from each councilmanic
10 district who is knowledgeable in the field of economics, finance, fiscal planning,
11 or a related field; and

13 WHEREAS, Section 610(d) of the Charter provides that each member of the
14 Spending Affordability Committee shall be appointed for a term of four years not
15 to exceed two successive terms; and

16
17 WHEREAS, the member from District 4 has resigned from a term that will expire
18 on December 1, 2016, and the position will become vacant; and

19
20 WHEREAS, the County Executive, subject to confirmation by the County
21 Council, has appointed Jerome W. Klasmeier, a resident of District 4, to serve on
22 the Spending Affordability Committee for the remainder of a term beginning on
23 November 15, 2016 and ending on December 1, 2016, and for a full term
24 beginning on December 1, 2016 and ending on December 1, 2020; and



26 WHEREAS, the County Council, after public hearing, finds that Jerome W.
27 Klasmeier meets the eligibility requirements under Section 610 of the Charter to
28 serve on the Spending Affordability Committee; now, therefore, be it

30 *Resolved by the County Council of Anne Arundel County, Maryland,* That it hereby
31 approves the appointment of Jerome W. Klasmeier as the District 4 member of the
32 Spending Affordability Committee, for the remainder of a term beginning on November
33 15, 2016 and ending on December 1, 2016, and for a full term beginning on December 1,
34 2016 and ending on December 1, 2020; and be it further
