1 RESOLUTION supporting the County's application to the Maryland Department of
2 Commerce to create an Enterprise Zone in Anne Arundel County

4 WHEREAS, Maryland's Enterprise Zone Tax Credit Program is a joint effort
5 between the State and local government to provide tax incentives to businesses and
6 property owners located in economically distressed communities; and

8 WHEREAS, Anne Arundel County has identified 1,572 acres, more or less, of
9 commercial- and industrial-zoned properties within a Priority Funding Area, as
10 more fully shown on Exhibit A attached hereto (the "proposed Enterprise Zone"),
11 as eligible under the Economic Development Article, § 5-704, of the State Code for
12 designation as an Enterprise Zone; and

14 WHEREAS, designation as an Enterprise Zone makes certain businesses and
15 property owners eligible for real property tax credits, income tax credits, and
16 financial assistance, as described in the Economic Development Article, § 5-707,
17 the Tax-Property Article, § 9-103, and the Tax-General Article, § 10-702, of the
18 State Code; and

20 WHEREAS, the County Executive and the County Council recognize the
21 Enterprise Zone designation as an incentive to encourage existing businesses to
22 expand, to encourage redevelopment of under-utilized commercial properties, and
23 to persuade businesses to locate within the Enterprise Zone area; now, therefore, be
24 it

26 *Resolved by the County Council of Anne Arundel County, Maryland,* That the County
27 Council hereby supports the County's application for designation of the proposed
28 Enterprise Zone; and be it further

29
30 *Resolved,* That a copy of this Resolution be sent to County Executive Steven R. Schuh
31 for endorsement indicating his support of the County's application for designation of the
32 proposed Enterprise Zone; and be it further

33
34 *Resolved,* That a copy of this Resolution be sent to Anne Arundel Economic
35 Development Corporation for inclusion with the County's application for designation of the
36 proposed Enterprise Zone.





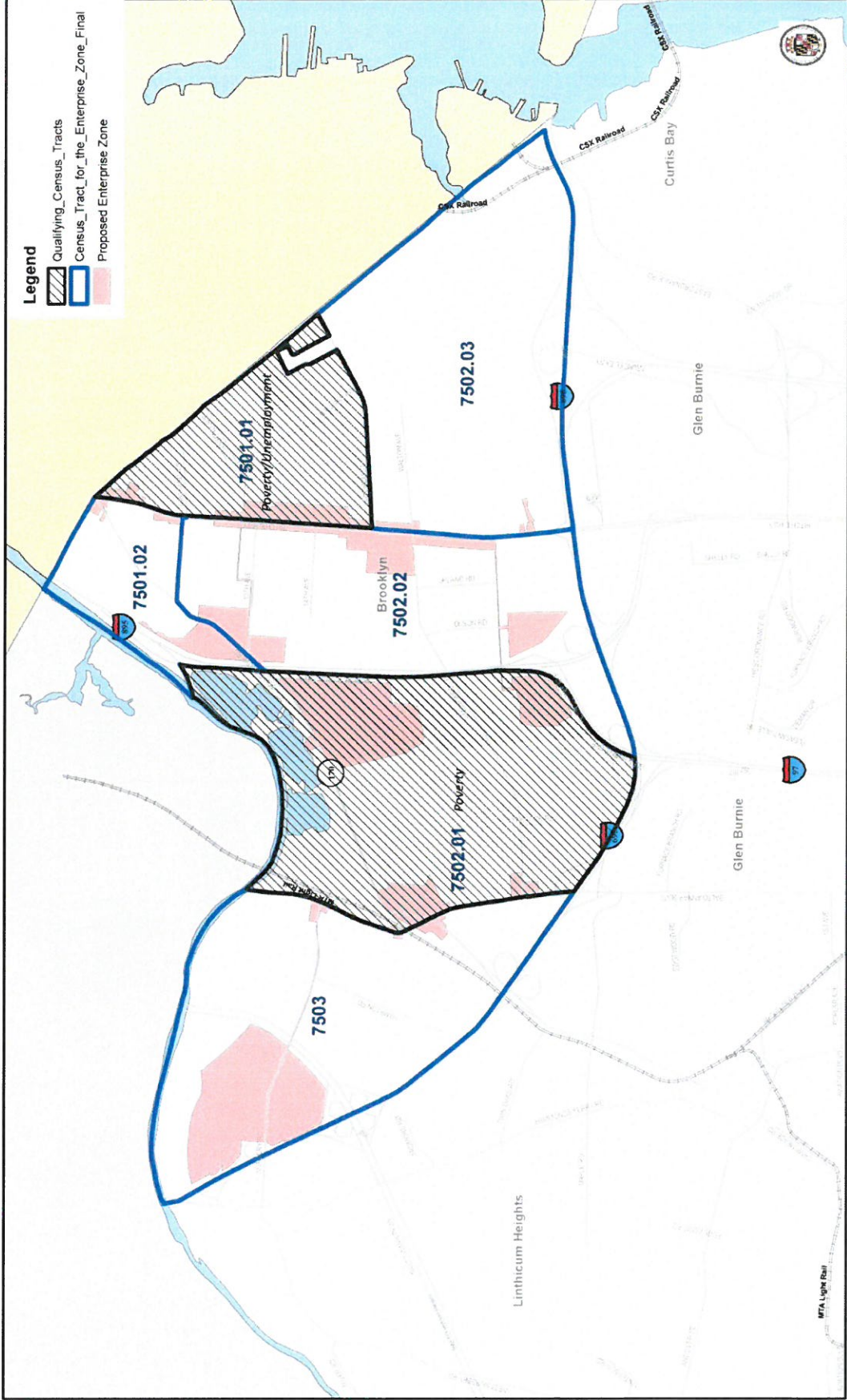
