5	WHEREAS, § 18-2-102 of the County Code states that it is the policy of the
6	County to guide and direct the development of land and the location of public
7	facilities and services in accordance with the General Development Plan; and

9	WHEREAS, § 18-2-104(f) of the County Code further dictates that the General
10	Development Plan shall be subject to a comprehensive review by the Office of
11	Planning and Zoning at intervals not to exceed ten years; and

13	WHEREAS, the current General Development Plan was approved by the County
14	Council on October 19, 2009 by Bill No. 64-09 and amended by Bill No. 12-15;

17	WHEREAS, since the adoption of the 2009 General Development Plan, County
18	zoning maps have been continually modified by legislation, leading to an
19	increased need for public resources;
20	WHEREAS, additional legislative changes to Article 18 of the County Code have
21	also had an impact on the use and intensity of growth throughout the County; and

24	WHEREAS, the County Council has witnessed growing citizen concern over
25	development that indicates there could be a great benefit to the citizens if the
26	County were to begin reviewing its plans for growth now, rather than waiting two

30	for the comprehensive review of the 2009 General Development Plan and plans
