1 RESOLUTION appointing a member to the Anne Arundel County Ethics  
2 Commission

4 WHEREAS, Section 1001 of the Charter establishes the Anne Arundel County  
5 Ethics Commission, whose members are appointed by the County Executive with  
6 the approval of the County Council; and

8 WHEREAS, the Ethics Commission has seven members, of which no more than  
9 four shall be members of the same political party; and

10  
11 WHEREAS, one of the current members of the Ethics Commission, Johnathan P.  
12 Kagan, Esquire (Democrat), with a term expiring April 30, 2019, resigned on  
13 August 2, 2017; and

15 WHEREAS, the County Executive, subject to the approval of the County Council,  
16 has appointed Thomas J. Mulrenin, Esquire (Democrat) to serve the remainder of  
17 a term expiring on April 30, 2019; and



19 WHEREAS, the County Council, after public hearing, has found Thomas J.  
20 Mulrenin, Esquire to be qualified under Section 1001 of the Charter to serve on  
21 the Ethics Commission; now, therefore, be it

23 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*  
24 *approves the appointment of Thomas J. Mulrenin, Esquire (Democrat) to the Anne*  
25 *Arundel County Ethics Commission to serve the remainder of a term expiring on April*  
26 *30, 2019; and be it further*


