1 RESOLUTION confirming the reappointment of certain members to the Pension  
2 Oversight Commission for Anne Arundel County

3  
4 WHEREAS, the Charter of Anne Arundel County, Maryland, Section 606(a)  
5 provides that there shall be a Pension Oversight Commission that is independent  
6 of both the legislative and executive branches of the County government; and

7  
8 WHEREAS, the Charter, Section 606(b)(1) provides that the Pension Oversight  
9 Commission shall consist of nine members appointed by the County Executive  
10 and confirmed by resolution of the County Council; and

11  
12 WHEREAS, the Charter, Section 606(b)(2) provides that five members shall be  
13 residents of the County who are knowledgeable about pension administration and  
14 funding, do not hold an elective or appointed office with the County or State of  
15 Maryland, and are not participants in any retirement plan that the Commission  
16 oversees; and

17  
18 WHEREAS, the Charter, Section 606(c)(1) provides that the term of a member  
19 shall be four years; and

20  
21 WHEREAS, the Charter, Section 606(c)(4) provides that a person may not serve  
22 for more than two terms as a member of the Pension Oversight Commission; and

23  
24 WHEREAS, the initial terms of County resident members Jon Pilon and Dr.  
25 Susan Duncan expire January 31, 2018; and

27 WHEREAS, the County Executive has reappointed, subject to confirmation by  
28 the County Council, County residents Jon Pilon and Dr. Susan Duncan to second  
29 terms commencing on February 1, 2018, and expiring on January 31, 2022; and

31 WHEREAS, the County Council, after public hearing, finds that Jon Pilon and Dr.  
32 Susan Duncan meet the eligibility requirements under the Anne Arundel County  
33 Charter, Section 606(b)(2), and are qualified to serve second terms on the Pension  
34 Oversight Commission; now, therefore, be it

36 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*  
37 approves the reappointment to the Pension Oversight Commission of County residents


1 Jon Pilon and Dr. Susan Duncan to second terms commencing on February 1, 2018, and
