1 RESOLUTION approving the recommendation of Billie Penley continuing to serve as
2 Acting Health Officer

4 WHEREAS, pursuant to § 3-302 of the Health General Article of the State Code,
5 the Health Officer is a State employee who is nominated by the County and
6 appointed by the State Secretary of Health (the “Secretary”); and

7
8 WHEREAS, pursuant to § 2-1-603 of the County Code, the County Executive
9 forwards the name of a nominee for the position of Health Officer to the County
10 Council, and, if the County Council approves, the name of the nominee is
11 forwarded to the Secretary; and

13 WHEREAS, there is no procedure in State law for appointment of an acting Health
14 Officer, but the Secretary has agreed that the Secretary may appoint an acting
15 Health Officer on the recommendation of the County; and

17 WHEREAS, upon recommendation of former County Executive Steven R. Schuh
18 and approval of that recommendation by the County Council through adoption of
19 Resolution No. 37-18, Billie Penley has served as Acting Health Officer since
20 August 29, 2018; and

22 WHEREAS, the County Executive is recommending that Billie Penley continue to
23 serve as Acting Health Officer from March 1, 2019, ~~until a Health Officer is~~
24 ~~appointed by the Secretary~~ through June 1, 2019; and



27 recommendation, the recommendation will be forwarded to the Secretary for
28 action; now, therefore, be it
