SUMMARY OF LEGISLATION

The purpose of this legislation is to amend the FY 2023 Capital Budget and Program by making a supplementary appropriation of funds to the Board of Education capital projects; Security Related Upgrades, Maintenance Backlog, Roof Replacement, and Upgrade Various Schools.

FISCAL IMPACT

This request will increase the Board of Education's level of appropriation in the E Class capital projects specified below by a total of \$3,334,000. This increase is the result of an increase in State grant funding and does not include any additional county funds. Below is a summary of the respective projects, the grant funding as indicated in the FY 2023 Approved Capital Budget and Program and their requested supplemental amounts.
