1 RESOLUTION approving the nomination of a member to the Anne Arundel County
2 Human Relations Commission

3
4 WHEREAS, Section 3-5A-101 of the County Code provides that there is a Human
5 Relations Commission to be known as the Anne Arundel County Human Relations
6 Commission (“Commission”); and

7
8 WHEREAS, Section 3-5A-102 of the County Code provides that the purpose of the
9 Commission is to promote and enhance the ability of all Anne Arundel County
10 residents to pursue their lives free of discrimination; and

11
12 WHEREAS, Section 3-5A-103 of the County Code provides that the Commission
13 shall consist of 11 voting members, all of whom shall be residents of the County,
14 nominated by the County Executive and approved by resolution of the County
15 Council; and

16
17 WHEREAS, Section 3-5A-103 of the County Code further provides that seven of
18 the members shall be from each councilmanic district and recommended by the
19 County Council member of the district, and four of the members shall be
20 recommended by the County Executive; and

21
22 WHEREAS, Section 3-5A-104(c) provides that vacancies shall be filled for an
23 unexpired term in the manner of original appointment; and

24
25 WHEREAS, Section 3-5A-104 of the County Code provides that the initial terms
26 of the members shall be staggered so that four members shall serve initial terms of
27 one year, four members shall serve initial terms of two years, and three members
28 shall serve initial terms of three years, and that after the expiration of the initial
29 terms, all members shall serve three year terms.; and

31 WHEREAS, Mohan Grover, a member from District 7, was nominated by the
32 County Executive and approved to serve an initial two year term commencing on
33 November 18, 2019, and ending on November 17, 2021; and

35 WHEREAS, Mohan Grover resigned on October 22, 2020, and his position remains
36 vacant; and

1 WHEREAS, pursuant to Section 3-5A-103(a)(1) of the County Code, the
2 Councilmember from District 7 has recommended and the County Executive has
3 nominated, subject to approval by the County Council, Jikaela L. Call, a resident
4 of District 7, serve the remainder of a term ending November 17, 2021, and to serve
5 a full term ending on November 17, 2024; and


7 WHEREAS, the County Council, after public hearing, finds that Jikaela L. Call
8 meets the eligibility requirements under Section 3-5A-103 of the County Code and
9 is qualified to serve on the Commission; now, therefore, be it

11 *Resolved by the County Council of Anne Arundel County, Maryland*, That it hereby
12 approves the nomination to the Anne Arundel County Human Relations Commission of
13 Jikaela L. Call, to serve as a representative of District 7 for the remainder of a term ending
14 November 17, 2021, and to serve a full term ending on November 17, 2024; and be it
