1 RESOLUTION nominating a member to serve on the Anne Arundel County Ethics
2 Commission

4 WHEREAS, Section 1001 of the County Charter establishes the Anne Arundel
5 County Ethics Commission to consist of seven members who are appointed by the
6 County Executive with the approval of the County Council; and

8 WHEREAS, Section 1001 states that, of the seven members of the Ethics
9 Commission, no more than four members shall be members of the same political
10 party; and

11
12 WHEREAS, Section 1001 further states that three members appointed by the
13 County Executive shall first be nominated by the County Council; and

14
15 WHEREAS, Section 1001 further states that the term of each member is four years
16 and that no member may serve more than two consecutive terms; and

18 WHEREAS, the second term of member Katherine K. Cawood (Democrat), who
19 was nominated by the County Council and appointed by the County Executive,
20 expired on April 30, 2020; now, therefore, be it

22 *Resolved by the County Council of Anne Arundel County, Maryland,* That it hereby
23 approves the nomination of Daniel J. Semick (Democrat) to serve as a member of the Anne
24 Arundel County Ethics Commission for a first term expiring on April 30, 2024; and be it

27 *Resolved,* that the County Council requests that the County Executive appoint Daniel
28 J. Semick (Democrat) to the Anne Arundel County Ethics Commission to serve a first term
29 that expires on April 30, 2024; and be it further

32 Michael Botsaris, Executive Director, Ethics Commission; Daniel J. Semick, nominee; and
