14	funding, do not hold an elective or appointed office with the County or State of

18	WHEREAS, Section 606(c)(1) of the Charter provides that the term of a member
19	shall be four years; and

21	WHEREAS, Pension Oversight Commission member Elizabeth Jane Buck, a
22	County resident, with a term expiring January 31, 2020, has resigned; and

24	WHEREAS, subject to confirmation by the County Council, the County Executive
25	has appointed County resident Sherri S. Voelkel to serve the remainder of the term
26	expiring on January 31, 2020, and to serve a full term expiring on January 31, 2024;

29	WHEREAS, the County Council, after public hearing, finds that Sherri S. Voelkel,
30	a County resident, meets the eligibility requirements under Charter Section
31	606(b)(2), and is qualified to serve on the Pension Oversight Commission; now,
