4	WHEREAS, § 14-402(a)(1) of the Family Law Article of the State Code requires
5	that the Anne Arundel County Adult Public Guardianship Review Board consist of
6	11 members appointed by the County Executive with the advice and consent of the
7	County Council; and

9	WHEREAS, § 14-402(a)(2) of the Family Law Article of the State Code requires
10	that, of the 11 members, one shall be a professional representative of a local
11	department of social services; one shall be a physician's assistant, nurse
12	practitioner, or physician who is not a psychiatrist; one shall be a psychiatrist; one
13	shall be a representative of a local commission on aging; one shall be a professional
14	representative of a local nonprofit social service organization; one shall be a lawyer;
15	two shall be lay individuals; one shall be a registered nurse; one shall be a
16	professional in the field of disabilities; and one shall be a person with a physical
17	disability; and

19	WHEREAS, § 14-402(b) of the Family Law Article of the State Code provides that
20	the term of a member is three years, that, at the end of a term, a member continues
21	to serve until a successor is appointed and qualifies, and that a member who is
