8	Executive and confirmed by resolution of the County Council; and

11	by the County Executive and confirmed by resolution of the County Council shall
12	represent each of the County's councilmanic districts, and the eighth member shall
13	be at large; and

15	WHEREAS, as stated in the Bylaws, the term of a member of the AACPL Board
16	of Trustees is 3 years; and

18	WHEREAS, the position of the member of the AACPL Board of Trustees from Councilmanic District 1 is vacant; and
19	Councilmanic District 1 is vacant, and

23	from Councilmanic District 1 for a term of 3 years beginning upon final

26	WHEREAS, the County Council, after a public hearing, finds that Laura Brown
27	meets the eligibility requirements and is qualified to serve on the AACPL Board of
28	Trustees; now, therefore, be it

31	the nomination of Laura Brown, a resident of Councilmanic District 1, to serve on the
