1 RESOLUTION amending Resolution No. 42-14 to clarify and specify the properties
2 within the Odenton Town Center Development District and to remove a restriction from
3 establishing a special taxing district in the Odenton Town Center Development District
4

5 WHEREAS, Resolution No. 42-14, adopted by the County Council of Anne
6 Arundel County, Maryland (the "County") on October 20, 2014 and approved by
7 the County Executive on October 24, 2014, among other things, created a
8 development district designated as the "Odenton Town Center Development
9 District" (the "Development District") pursuant to the authority set forth in the
10 Economic Development Article, §§ 12-201 through 12-213, of the State Code (the
11 "Act"); and
12

13 WHEREAS, Resolution No. 42-14 included, as Exhibit 1, a list of parcels that
14 comprised the Development District; and
15

16 WHEREAS, a restriction set forth in Section 9 of Resolution No. 42-14,
17 originally added by amendment of the County Council, prevents the County from
18 establishing a special taxing district for any of the parcels located within the
19 Development District as a condition to the issuance of tax increment revenue
20 bonds; and
21

22 WHEREAS, the County Council now desires to clarify and specify the property
23 that comprises the Development District by replacing Exhibit 1 to Resolution No.
24 42-14 with a new list of property designated by tax account identification number;
25 and
26

27 WHEREAS, the County Council now desires to remove the restriction to allow
28 for the creation of a special taxing district within the boundaries of the
29 Development District as a condition to the issuance of certain tax increment
30 revenue bonds, but with the area of the special taxing district being limited to
31 parcels comprising 12.438 acres, more or less, to be designated as the "Odenton
32 Town Center Special Taxing District I", and as shown on the map attached hereto
33 as Exhibit A; now, therefore, be it

1 Resolved by the County Council of Anne Arundel County, Maryland, That the County
2 Council hereby repeals and reenacts, with amendments, Resolution No. 42-14, Section 4,
3 Laws of Anne Arundel County, 2014, as follows:

5 Resolution No. 42-14

7 SECTION 4. And be it further resolved, That a contiguous area of the County
8 consisting of the tax lots and other property herein described is hereby designated as a
9 "development district" to be known as the "Odenton Town Center Development District"
10 pursuant to Section 12-203 of the Act. The Development District shall consist of the
11 property listed in REVISED Exhibit 1 to this Resolution designated by tax [lots] ACCOUNT
12 IDENTIFICATION NUMBER and all adjoining roads, highways, alleys, rights of way, parks
13 and other similar property in order to form a contiguous area as shown on the maps
14 submitted to the County Council together with this Resolution and shown in Exhibit 2 to
15 this Resolution.

20 Council hereby repeals Resolution No. 42-14, Section 9, Laws of Anne Arundel County,
21 2014, and rennumbers Sections 10, 11, and 12, as follows:

25 ~~[SECTION 9. And be it further resolved, That the County may not require, as a~~
26 ~~condition to the issuance of increment revenue bonds, that a special taxing district be~~
27 ~~established for any of the parcels located within the Development District under Section~~
28 ~~21-503 of the Local Government article of the Annotated code of Maryland or under~~
29 ~~Section 4-8-101 of the Anne Arundel County Code.]~~

31 SECTION [10.] 9. *And be it further resolved,* That the provisions of this
32 Resolution are severable, and if any provision, sentence, clause, section or part hereof is
33 held or determined to be illegal, invalid or unconstitutional or inapplicable to any person
34 or circumstances, such illegality, invalidity or unconstitutionality or inapplicability shall
35 not affect or impair any of the remaining provisions, sentences, clauses, sections or parts
36 of this Resolution or their application to other persons or circumstances. It is hereby
37 declared to be the legislative intent that this Resolution would have been adopted if such
38 illegal, invalid, unconstitutional or inapplicable provision, sentence, clause, section or
39 part had not been included herein and as if the person or circumstances to which this
40 Resolution or any part hereof are inapplicable had been specifically exempted herefrom.

42 SECTION [11.] 10. *And be it further resolved,* That, if during a time when no Bonds
43 are outstanding, the Assessment Ratio mandated by State law is increased from that
44 which applied in determining the Original Assessable Base, it is the intent and
45 expectation of the County, to the extent permitted by law, that a supplemental resolution
46 will be adopted for the purpose of assuring that additional funds are not deposited in the
47 Special Fund as a result of the change in Assessment Ratio as compared to the amount of

1 funds that would have been required to be deposited in the Special Fund if the
2 Assessment Ratio had not been so increased.

3
4 SECTION [12.] 11. *And be it further resolved*, That this Resolution is administrative
5 in nature and shall take effect upon its approval by the County Executive.

9 *Resolved*, That Exhibit 1 to Resolution No. 42-14, Laws of Anne Arundel County
10 2014, is replaced by Revised Exhibit 1, attached hereto as Exhibit B; and be it further



16 its approval by the County Executive.



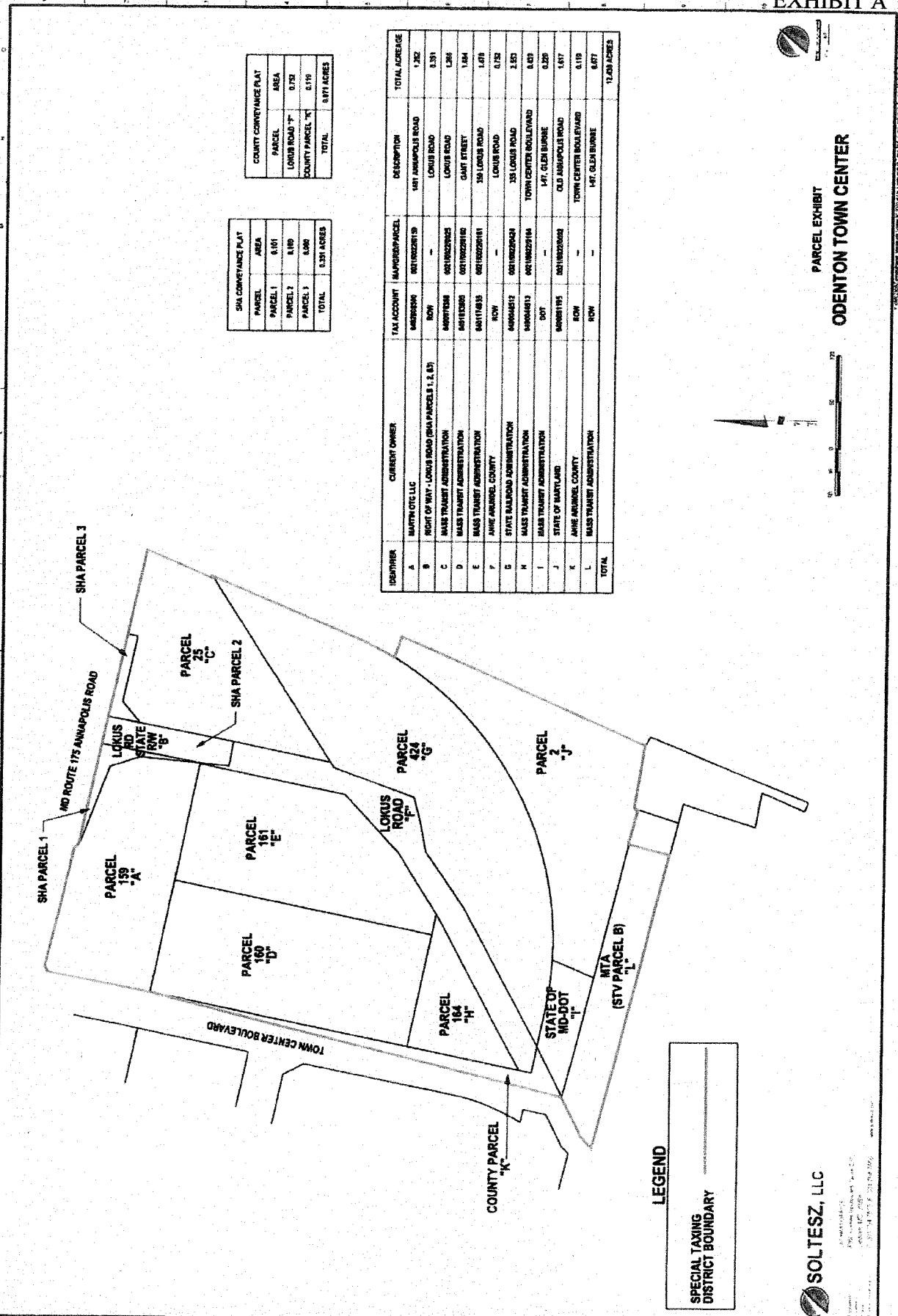
