## Dear Interested Hunter,

The Anne Arundel County Department of Recreation and Parks (AADRP), is pleased to announce that it will now be accepting applications for our 2024 Managed Hunt Program. Persons wishing to participate in our management efforts will find our application requirements outlined below.

Our selection of hunters will be based on each hunter having the credentials listed below, the completion of an application packet, and being interviewed by the Hunter Selection Committee. All applicants are also subject to records checks through the Maryland Natural Resources Police and State and Local Police.

At this time, we are still awaiting final approval of the exact hunting dates and culling restrictions. If no changes occur, they will be as published in the 2024 Managed Hunt Procedures, Rules & Regulations document. Hunters in our program are strongly urged to harvest as many antlerless deer as they can take safely and humanely. Our primary goal is to manage an overabundant deer population. **Participating hunters are required to provide their own climbing or ladder stand and required safety equipment for their use.** 

Please note that this hunt is being conducted as a natural resource management tool, not a recreational program, and we are dedicated to assuring the safety of the residents in the area and the participating hunters, as well as the humane treatment of the deer.

All hunters must provide the following:

- 1. Participant Information Form (including a Questionnaire for new hunters)
- 2. Proof of Maryland Residency (Valid MD License or ID, or Military ID with Maryland residency proof).
- 3. A \$25.00 non-refundable administrative processing fee payable to Anne Arundel County (previous season participants must pay this fee as well).
- 4. <u>Recreation & Parks Volunteer Background Check</u>. Please refer to page 4 of the 2024 Managed Hunt Procedures, Rules & Regulations document for detailed information. This includes a separate \$7.00 fee.

The application deadline for the 2024 season is 4:00 PM on Friday, August 23, 2024. Any applications received after this date and time will be held for the next management season. All previous year Anne Arundel County managed hunt participants in good standing will be pre-approved, but must complete all relevant requirements on page 3 of the 2024 Managed Hunt Procedures, Rules & Regulations document.

Checks/money orders should be mailed or delivered to the address listed above.

Qualified applicants (new hunters) will be contacted and scheduled for an in-person interview on either Tuesday, September 3, 2024 or Wednesday, September 4, 2024. Individuals who successfully pass the interview process and other prerequisites will be accepted into the program. Hunters who do not pass our requirements will be contacted by phone. Accepted applicants will then need to provide the following items before they will be allowed to participate in a hunt:

- 5. A \$50.00 registration fee payable to the Friends of Jug Bay (these funds are returned directly to the Deer Management Program for supplies) (previous season participants must pay this fee as well).
- 6. Valid 2024-2025 Maryland Hunting License.
- 7. Valid Hunter Safety Card.
- 8. 2024-2025 Maryland Shooter Qualification Card for the firearm type(s) to be used during the hunt.

Accepted applicants (new hunters) will be required to attend a mandatory in-person meeting on the evening of Monday, September 9, 2024. Returning hunters will have the option to attend the in-person meeting, or a virtual meeting on the evening of Tuesday, September 10, 2024.

New hunters to our program must attend a scout day with a Park Ranger on the properties they intend to hunt. Scout days have been scheduled on Saturdays and Sundays in mid-September 2024. All hunters will complete and submit a Managed Deer Hunt Lottery Form (to be provided) to communicate their hunt date, location and stand preferences. **Lottery forms will be due on Monday, September 23, 2024**, and the results of the lottery will be distributed on Monday, September 30, 2024.

We thank you for your interest in this program and look forward to a safe and successful hunt.
