PUBLIC OUTREACH ANNOUNCEMENT – PLEASE SHARE WITH YOUR COMMUNITY Blue Water Blvd Shared-Use Path, Annapolis Road to Regiment Way

WHO: Anne Arundel County Department of Public Works (DPW)

WHAT: Blue Water Blvd Shared-Use Path Project – Public Outreach

WHEN: Through September 10, 2023

WHERE: Online (see webpage and virtual public meeting information below)

A project webpage has been created by the Anne Arundel County Department of Public Works (DPW) to present the schematic-level design of a planned shared-use path along Blue Water Blvd from MD 175 (Annapolis Road) to Regiment Way. The project will upgrade the existing sidewalk on the north side of Blue Water Blvd to also accommodate bicyclists, closing gaps in existing paths between Odenton and BWI Thurgood Marshall Airport.

The webpage can be accessed by visiting www.aacounty.org/dpw-capital-projects and selecting "Blue Water Blvd Shared-Use Path – Annapolis Road to Regiment Way." The page includes text descriptions, engineering plans, and technical documentation. It also summarizes future stages of the project, each of which will include a separate public outreach phase. Construction is expected to start in spring 2025.
