A public meeting has been scheduled for **Wednesday, April 3, 2024** from **6:00-7:00 pm** via the **ZOOM.US** platform to discuss construction of a sidewalk along the southbound side of Baltimore Annapolis Boulevard (MD 648E) between Southbridge Drive and Marley Meadow Lane. The work will occur primarily within the right-of-way maintained by the State Highway Administration (SHA) and includes widening southbound Baltimore Annapolis Blvd to 27' along with adding approximately 285 linear feet of curb and gutter. The proposed widening of the southbound was requested by SHA to allow space for an 11'-wide through lane, a 5'-wide pocket bicycle lane, and an 11'-wide right turn lane in the future.

During the meeting, DPW will discuss this project, which is designed to provide a safe path for students, bicyclists, and pedestrians traveling in the area. Construction is expected to begin in spring 2024 and last about 8 weeks. We welcome your input on the project and the proposed schedule.
