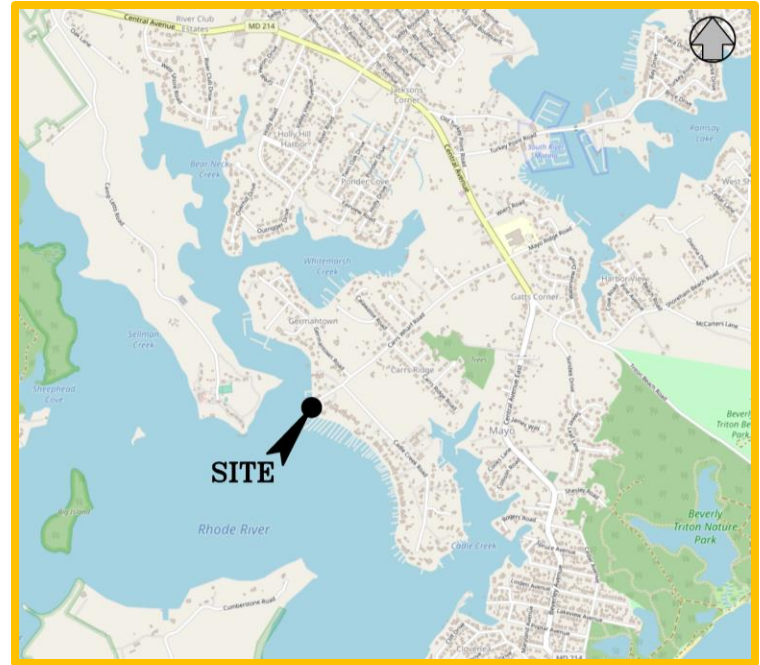

Project Background

- 30% Schematic Design Public Meeting – August 2023
- Park Operations Improvements
- Project's Scope of Work reduced
 - Emergency access elements removed
 - ADA accessibility elements remain
- Field investigations and concept design to address failing bulkhead performed – Any improvements will be implemented via future project



Park Operations Improvements

- Increased frequency of daily Park Ranger visits
- Additional Park Ranger visits on weekends
- Scheduled additional trash collections
- Bollards to restrict motorized watercraft launching
- Fence installed between County & Adjacent Property
- Closed end of pier due to structural damage from a boating accident



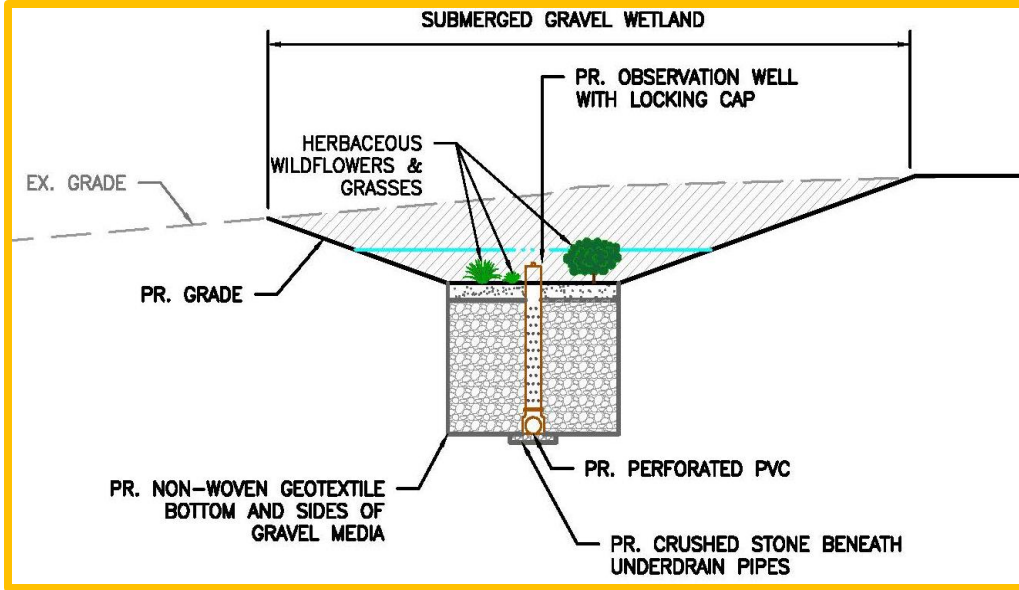
Proposed Design – Access Road

After one growing season

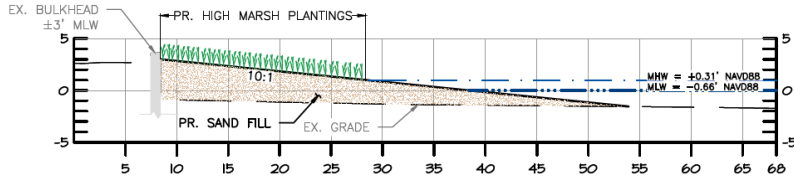


Environmental Resources and Protection

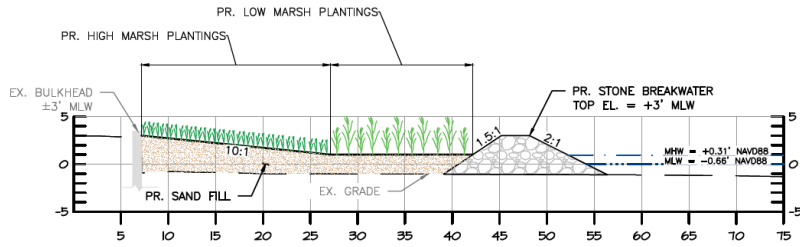
- Proposed improvements designed to minimize impacts
- Unavoidable impacts will be mitigated
 - Critical Area Mitigation for Lot Coverage & Canopy Loss
 - Approximately 3,000 square feet of mitigation is required
 - Replanting with native species in and around the gravel wetland



Shoreline Stabilization Concept Design

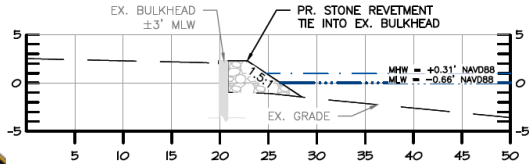


XS-01
