SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland*, That the maps of the Anne Arundel County Master Plan for Water Supply and Sewerage Systems, 2022, as amended (the "Plan") are hereby amended as follows:

1. As shown on Exhibit A, attached hereto, on Sewer Map S-4, move the properties known on Tax Map 30, Parcel 399; Tax Map 22, Parcel 6; and Tax Map 31, Parcel 371 out of the No Public Service category in the Rural Service Area into the Planned Service category in the Broadneck Service Area.

SECTION 2. And be it further enacted, That a certified copy of the Plan as amended by this Ordinance shall be permanently kept on file with the Administrative Officer to the County Council and the Office of Planning and Zoning.

SECTION 3. And be it further enacted, That a certified copy of the map amendments to the Plan shall be permanently kept on file with the Administrative Officer to the County Council and the Office of Planning and Zoning.

SECTION 4. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law or upon approval of the Maryland Department of the Environment under the authority granted by § 9-507 of the Environment Article of the State Code, whichever is later. If approved, in whole or in part, after the 45 days the approved

- provisions of this Ordinance shall take effect on the date the notice is received by the Office
- of Planning and Zoning. If disapproved, in whole or in part, the disapproved portions of

- 5 Department of the Environment, shall forward a copy to the Administrative Officer to the
