1 RESOLUTION confirming the appointment of a member of the classified service to
2 serve on the Pension Oversight Commission for Anne Arundel County

4 WHEREAS, Section 606(a) of the Charter provides that there shall be a Pension
5 Oversight Commission that is independent of both the legislative and executive
6 branches of the County government; and

7
8 WHEREAS, Section 606(b)(1) of the Charter provides that the Pension Oversight
9 Commission shall consist of nine members appointed by the County Executive and
10 confirmed by resolution of the County Council; and

11
12 WHEREAS, Section 606(b)(3) of the Charter provides that one member shall be a
13 member of a class represented by the employee organization that represents the
14 majority of classified employees other than uniformed police officers and
15 professional fire fighters; and

16
17 WHEREAS, Section 606(c)(1) of the Charter provides that the term of a member
18 shall be four years; and

19
20 WHEREAS, Section 606(c)(4) of the Charter provides that a person may not serve
21 for more than two terms as a member of the Pension Oversight Commission; and

22
23 WHEREAS, the second term of classified service member Robert Stull (a member
24 of a class represented by the employee organization that represents the majority of
25 classified employees other than uniformed police officers and professional fire
26 fighters) expired on January 31, 2024; and

28 WHEREAS, the County Executive, subject to confirmation by the County Council,
29 has appointed classified service member Michael Kropp (a member of a class
30 represented by the employee organization that represents the majority of classified
31 employees other than uniformed police officers and professional fire fighters) to a
32 term commencing on July 1, 2024, and expiring on June 30, 2028; and

34 WHEREAS, the County Council, finds that Michael Kropp meets the eligibility
35 requirements under Section 606(b)(3) of the Charter and is qualified to serve on the
36 Pension Oversight Commission; now, therefore, be it

1 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*
2 *approves the appointment to the Pension Oversight Commission of Michael Kropp to an*
3 *initial term commencing on July 1, 2024, and expiring on June 30, 2028; and be it further*

5 *Resolved, That a copy of this Resolution be sent to County Executive Steuart Pittman,*
6 *and to Vincent Carbonaro, Chair, Pension Oversight Commission.*
