1 RESOLUTION supporting the application to the Main Street Maryland affiliate
2 program by the Department of Housing and Community Development (the “Department”)
3 and the local administration of the Main Street Maryland affiliate program by Anne
4 Arundel Economic Development Corporation for the Glen Burnie Town Center in Glen
5 Burnie, Maryland

7 WHEREAS, the County Executive and County Council recognize that there is a
8 significant need for continued reinvestment and revitalization of the Glen Burnie
9 Town Center, as shown on Exhibit A, attached hereto and made a part hereof; and

11 WHEREAS, the County Executive and County Council have made a commitment
12 to improve the economy, appearance, and image of their traditional downtown
13 business districts; and

15 WHEREAS, a local organization, Anne Arundel Economic Development
16 Corporation, will implement a comprehensive revitalization strategy, based on the
17 Department’s Main Street Maryland affiliate program, which utilizes the Main
18 Street Four-Point Approach[®], to strengthen the economic potential of the historic
19 downtown and neighborhood business district; and

21 WHEREAS, the County Executive supports and endorses Anne Arundel Economic
22 Development Corporation administering the local Main Street Maryland program
23 for Glen Burnie Town Center for the County, including the execution of documents
24 and the taking of other necessary actions by its President and CEO; now, therefore,

27 *Resolved by the County Council of Anne Arundel County, Maryland,* That it supports
28 and endorses Anne Arundel Economic Development Corporation administering the local
29 Main Street Maryland program for Glen Burnie Town Center for the County, including the

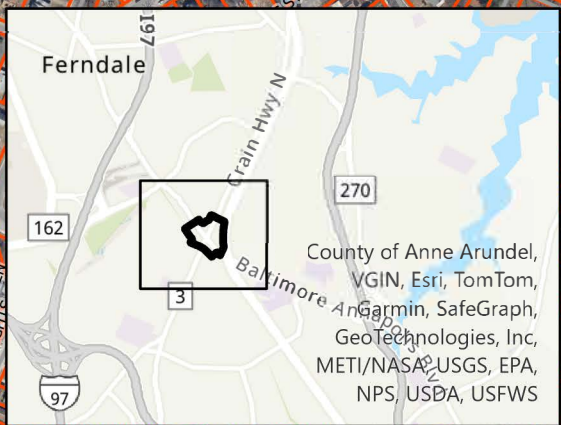
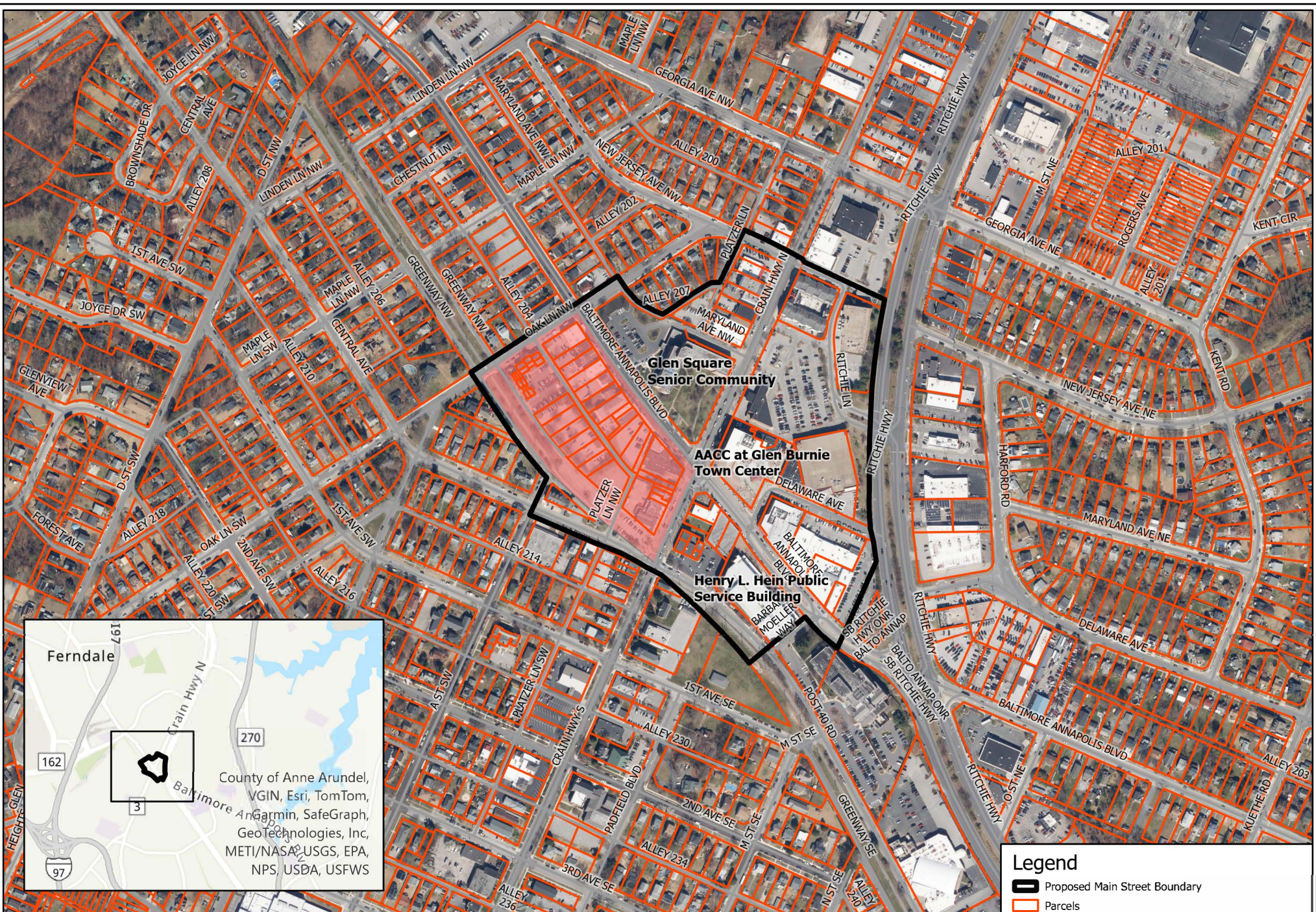
