4	FOR the purpose of amending the definition of "second-hand dealer" to exempt the sale of
5	certain goods requiring a license; and generally related to licenses and registrations.

7	BY repealing and reenacting, with amendments: § 11-12A-101(a)
8	Anne Arundel County Code (2005, as amended)

10	SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland,
11	That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

13	ARTICLE 11. LICENSES AND REGISTRATIONS

15	TITLE 12A. SECOND-HAND DEALER LICENSE
16	
17	11-12A-101. Second-hand sales.
18	
19	(a) <b>Definition.</b> In this title, "second-hand dealer" means a person who acquires
20	commercially from the public and trades commercially with the public in tangible personal
21	property, but the term does not include a pawnbroker; a business that deals primarily with

the purchase and sale of antiques; a charitable organization that accepts only donations; garage or yard sales; the purchase on consignment of second-hand clothing, furniture,

books, or baby accessories and toys; activities of a club, school, church, or charitable

organization that include the sale of donated items; A BUSINESS THAT DEALS PRIMARILY

WITH THE SALE OF CHILDREN'S CLOTHING; or auctions, estate sales, conventions, or trade shows.
