1	RESOLUTION approving the application of Steven Maurice Parks, Jr. to sell an
2	agricultural land preservation easement to the Maryland Agricultural Land Preservation
3	Foundation on 94.84 acres in Lothian, Maryland

5	WHEREAS, Steven Maurice Parks, Jr. has made application (the "Parks
6	Application") to the Maryland Agricultural Land Preservation Foundation (the
7	"Foundation") to sell an agricultural land preservation easement on real property
8	known as 710 Bayard Road in Lothian, Maryland, described in a deed dated
9	August 1, 2023, recorded in the land records of Anne Arundel County, Maryland,
10	in Book 39985, Page 298, consisting of 94.84 acres, more or less, and shown
11	generally on Exhibit 1, a copy of which is attached hereto (the "Parks Property");
12	and

14	WHEREAS, pursuant to Title 2, Subtitle 5 of the Agriculture Article of the State
15	Code and regulations adopted pursuant thereto, the County governing body is
16	required to advise the Foundation as to a local recommendation of approval or
17	disapproval of the Parks Application; and
18	
19	WHEREAS, in deciding whether to approve the Parks Application, the County
20	governing body is to receive the recommendation of the Office of Planning and
21	Zoning and the County Agricultural Preservation Advisory Board (the "Board")
22	based on criteria and standards identified in Title 2, Subtitle 5 of the Agriculture
23	Article of the State Code and regulations adopted pursuant thereto; and

25	WHEREAS, the Office of Planning and Zoning, the Board, and the County
26	Executive have recommended approval of the Parks Application; and
27	
28	WHEREAS, the County Council finds that approval of the Parks Application is in
29	the best interest of the citizens of Anne Arundel County; now, therefore, be it

31	Resolved by the County Council of Anne Arundel County, Maryland, That it hereby
32	approves the recommendation of approval of the Parks Application to sell an agricultural
