1 RESOLUTION approving the application of Allen P. Covington and Maxwell H.
2 Covington, III, individually and as Trustees of the Covington Marital Trust, to sell an
3 agricultural land preservation easement to the Maryland Agricultural Land Preservation
4 Foundation on 92.6 acres in Davidsonville, Maryland

6 WHEREAS, Allen P. Covington and Maxwell H. Covington, III, individually and
7 as Trustees of the Covington Marital Trust, have made application (the “Covington
8 Application”) to the Maryland Agricultural Land Preservation Foundation (the
9 “Foundation”) to sell an agricultural land preservation easement on real property
10 known as 3208 Davidsonville Road in Davidsonville, Maryland, described in a
11 deed dated December 6, 2022, recorded in the land records of Anne Arundel
12 County, Maryland, in Book 39557, Page 41, in a deed dated December 30, 1992,
13 recorded in land records of Anne Arundel County, in Book 5883, Page 36, and in a
14 deed dated December 30, 1992, recorded in land records of Anne Arundel County,
15 in Book 5883, Page 39, consisting of 92.6 acres, more or less, and shown generally
16 on Exhibit 1, a copy of which is attached hereto (the “Covington Property”); and

18 WHEREAS, pursuant to Title 2, Subtitle 5 of the Agriculture Article of the State
19 Code and regulations adopted pursuant thereto, the County governing body is
20 required to advise the Foundation as to a local recommendation of approval or
21 disapproval of the Covington Application; and

23 WHEREAS, in deciding whether to approve the Covington Application, the County
24 governing body is to receive the recommendation of the Office of Planning and
25 Zoning and the County Agricultural Preservation Advisory Board (the “Board”)
26 based on criteria and standards identified in Title 2, Subtitle 5 of the Agriculture
27 Article of the State Code and regulations adopted pursuant thereto; and

29 WHEREAS, the Office of Planning and Zoning, the Board, and the County
30 Executive have recommended approval of the Covington Application; and

32 WHEREAS, the County Council finds that approval of the Covington Application
33 is in the best interest of the citizens of Anne Arundel County; now, therefore, be it

35 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*
36 *approves the recommendation of approval of the Covington Application to sell an*

1 agricultural land preservation easement on the Covington Property to the Foundation; and
2 be it further

4 *Resolved*, That a copy of this Resolution be sent to County Executive Steuart Pittman;
5 Eddie Franceschi, Agricultural and Woodland Preservation Program Manager at the Office
6 of Planning and Zoning; and Michelle Cable, Executive Director of the Maryland
7 Agricultural Land Preservation Foundation.

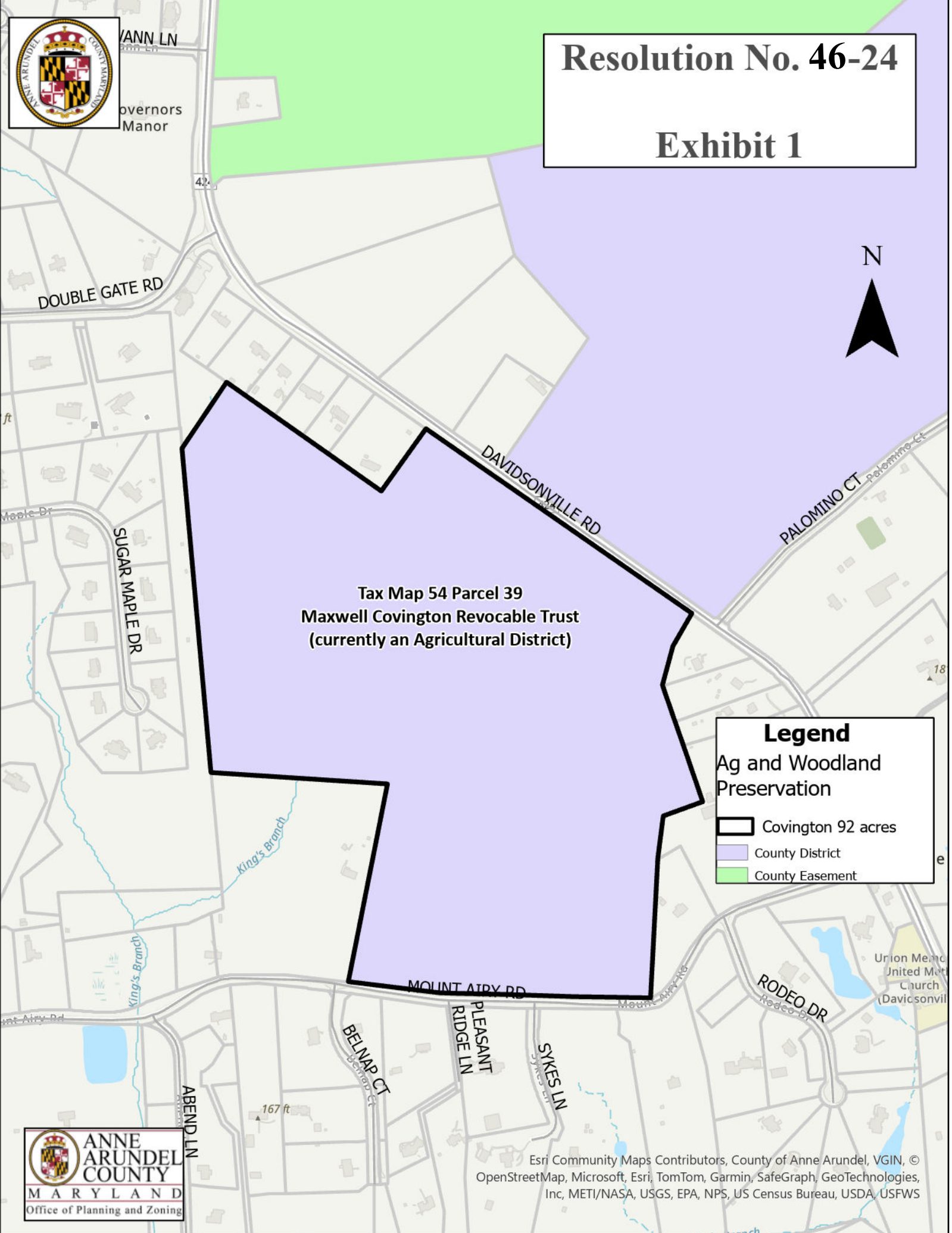
