A blank means that the use is not allowed in the district. Except as provided otherwise in this article, uses and structures customarily accessory to permitted, conditional, and special exception uses also are allowed.

# TITLE 10. REQUIREMENTS FOR CONDITIONAL USES

## 18-10-156. School Bus Facilities.

A school bus facility shall comply with all of the following requirements.

\*\*\*

- (10) Vehicular access IN C3 ZONING DISTRICTS shall be from an arterial road or from a local or higher classification road that directly accesses an arterial road.
- (11) IN C1 ZONING DISTRICTS, THE FACILITY SHALL BE LOCATED ON A LOT OR CONTIGUOUS LOTS THAT TOTAL AT LEAST FIVE (5) ACRES AND SHALL ADJOIN AN ARTERIAL ROAD.
- (12) VEHICULAR ACCESS IN C1 ZONING DISTRICTS SHALL BE BY DIRECT CONNECTION TO AN ARTERIAL ROAD.
- SECTION 2. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law.
