One of the responsibilities of the City of Annapolis Board of Supervisors of Elections is to appoint Election Judges to staff the Annapolis polling places for the 2025 City of Annapolis Municipal Elections. Election Judges are being recruited to work the September 16, 2025 Primary Election and the November 4, 2025 General Election.

The Anne Arundel County Board of Elections, on behalf of the City of Annapolis Board of Supervisors of Elections, is managing the recruitment, hiring, and training of election judges for the 2025 City of Annapolis Municipal Elections.
