While this legislation may aim to ensure transparency and compliance, it fails to consider the unique challenges smaller civic and community associations face. Many of these associations operate with extremely limited budgets, often relying on volunteers to fulfill key roles. The proposed 5% to 9% administrative charge and the potential for penalties and dissolution for non-compliance present a significant financial strain that could force smaller districts to redirect funds away from vital community programs to cover administrative costs. The burden of this financial impact is disproportionate and could stifle the ability of these organizations to effectively serve their communities.  Additionally, the requirement for associations to designate an officer to complete training on the Open Meetings Act is an admirable goal but one that further strains volunteer-driven associations.  For smaller groups with limited volunteer capacity, the mandate to identify and train an officer within 90 days represents an additional administrative challenge that could prove difficult to meet.  I urge you to reconsider these provisions, especially as they relate to smaller organizations that are already working with tight budgets and volunteer-driven management.
