4	FOR the purpose of amending the Capital Budget for the current fiscal year by transferring
5	an appropriation of funds from the Forest Dr./MD 665 Int. Imp. capital project to the
6	R & B Project Plan capital project; amending the Capital Program and Capital Projects
7	Bond Ordinance for the current fiscal year; and generally relating to appropriation of
8	funds in projects in the Capital Budget for the fiscal year ending June 30, 2025.

14	WHEREAS, the R & B Project Plan capital project, Project No. H545900, has an
15	existing appropriation; and

17	WHEREAS, Section 716 of the Charter authorizes the County Council, upon
18	request of the County Executive and by the affirmative vote of five members of the
19	County Council, to amend the capital budget; and
20	
21	WHEREAS, Section 711(b) of the Charter authorizes the County Council, upon
22	request of the County Executive, to transfer appropriations between capital projects
23	in the Capital Budget; and

25	WHEREAS, the County Executive is requesting that \$400,000 be transferred from
26	the Forest Dr./MD 665 Int. Imp. capital project, Project No. H587400, to the R & B
27	Project Plan capital project, Project No. H545900; and

WHEREAS, the Planning Advisory Board has recommended amendments to the 1 Capital Budget in accordance with Section 716 of the Charter; and 2 3 WHEREAS, the Controller has certified in writing that such funds are available for 4 appropriation; and 5 6 SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, 7 That the Capital Budget for the fiscal year ending June 30, 2025, is hereby amended by 8 transferring appropriations in the total amount of \$400,000 from the following capital 9 project: 10 11 Forest Dr./MD 665 Int. Imp., Project No. H587400 12 400.000 (General County Bonds) \$ 13 14 15 to the following capital project: 16 R & B Project Plan, Project No. H545900 17 18 (General County Bonds) \$ 400,000 19 SECTION 2. And be it further enacted, That the Capital Program and Capital Projects 20 Bond Ordinance for the fiscal year ending June 30, 2025, are hereby amended in 21 accordance with the provisions of this Ordinance. 22 23 24 SECTION 3.
