1 RESOLUTION concerning a petition to the Maryland Higher Education Commission
2 for Anne Arundel Community College funding to procure long lead equipment, including
3 elevator replacement and electrical switchgear for the Florestano Building Renovation
4 Floors 1 through 3

6 WHEREAS, the Maryland General Assembly has enacted various community
7 college loan acts that provide funds to assist the counties in the financing of the cost
8 of the acquisition of land and in the construction of public junior, community, or
9 regional community college buildings and facilities, the cost of which were
10 incurred after the effective dates of the acts; and

12 WHEREAS, § 11-105(j)(3)(i) of the Education Article of the Annotated Code of
13 Maryland requires that a county desiring to participate in the financial assistance
14 provided in the acts must file a petition with the Maryland Higher Education
15 Commission, together with a complete proposal for each project for which financial
16 assistance is desired; and

18 WHEREAS, the Board of Trustees of Anne Arundel Community College proposes
19 to procure long lead equipment, including elevator replacement and electrical
20 switchgear for the Florestano Building Renovation Floors 1-3 for the public
21 community college at Arnold, Maryland; and

23 WHEREAS, upon resolution duly adopted by it, a copy of which is appended
24 hereto, the Board of Trustees has requested Anne Arundel County to petition the
25 Maryland Higher Education Commission for the sum of \$384,933 needed for the
26 purpose of assisting the financing of the public community college project, which
27 is described in the application for financial assistance; and

29 WHEREAS, by this Resolution, the County Executive expresses his approval of
30 this project and requests that the County Council petition the Maryland Higher
31 Education Commission for the funding; now, therefore, be it

33 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*
34 *petitions the Maryland Higher Education Commission for a grant of \$384,933 from the*
35 *available funds of the various community college loan acts in order to participate in said*
36 *financial assistance; and be it further*

1 *Resolved*, That, subject to appropriation and availability of funds, the Anne Arundel
2 County Council shall provide all of the remaining funds necessary to complete the
3 described project even if the Maryland Board of Public Works approves a grant which is
4 less than the amount requested by this petition; and be it further
5

6 *Resolved*, That a copy of this Resolution be sent to County Executive Steuart Pittman
7 and to Dr. Dawn Lindsay, AACC President and the Secretary-Treasurer of the Board of
8 Trustees of Anne Arundel Community College.
