



## MD 2 Northbound (Arnold) - Safety and Accessibility Project

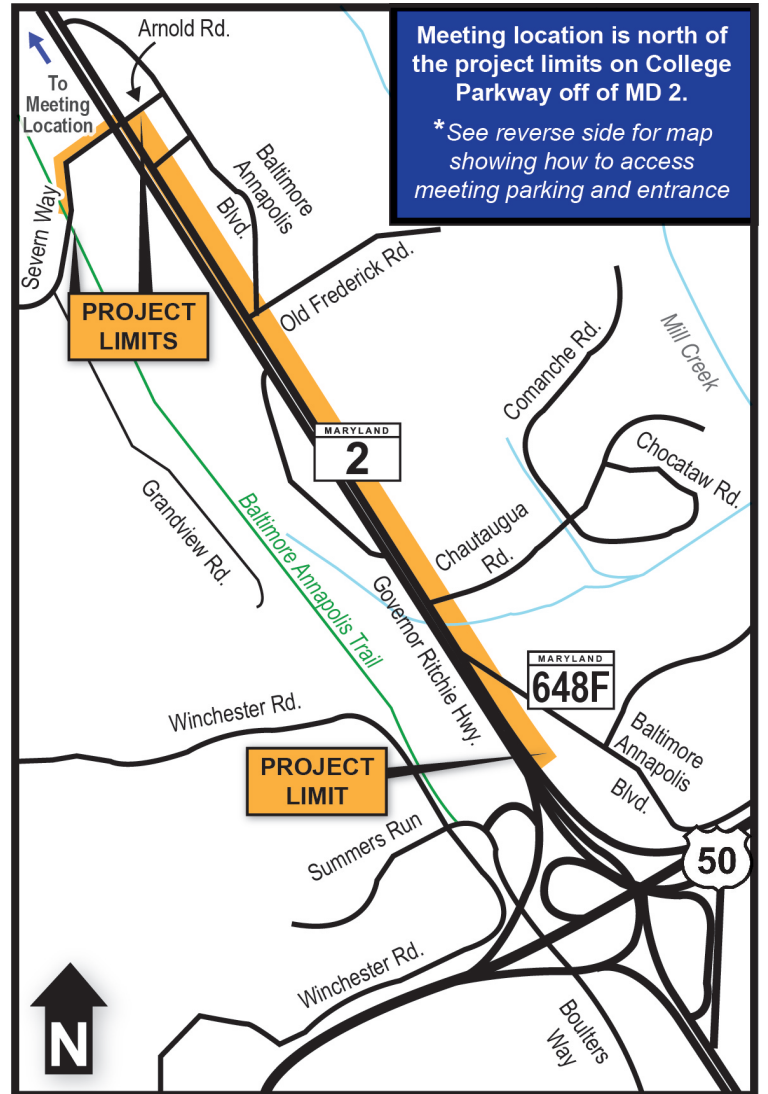
### Public Open House Scheduled for January 30, 2025

The Maryland State Highway Administration (SHA) invites you to attend a public open house for proposed improvements along northbound MD 2 in Anne Arundel County. The project extends from US 50 to Arnold Road. The design is currently 30% complete. The project team is seeking public input as the design continues toward the 65% design milestone.

### Project Overview

The purpose of the MD 2 project is to improve traffic operations, safety and pedestrian and bicycle connections. The scope of the project includes:

- a continuous third through-lane along northbound MD 2 from US 50 to Arnold Road,
- bicycle facilities from MD 648F (Baltimore Annapolis Boulevard) to Baltimore Annapolis Boulevard/Old Frederick Road,
- Americans with Disabilities Act (ADA)-compliant sidewalks and ramps from Chautaugua Road to Arnold Road,
- a shared-used path along westbound Arnold Road/ Severn Way from MD 2 to the Baltimore Annapolis Trail and,
- modifications to the existing intersection of Baltimore Annapolis Boulevard/Old Frederick Road.



### Attend the Public Open House

The State Highway Administration will hold a public open house, **5 - 7 p.m. Thursday, January 30, 2025, at Anne Arundel Community College (Dining Hall), 101 College Parkway, Arnold.** The open house will provide attendees with an opportunity to view project details on maps and displays. Project team members will be available to listen to your feedback and answer questions. This information may be used to improve and advance the development of the project. There will be no formal presentation. You may arrive at any time during the open house hours and walk through the display area at your own pace.

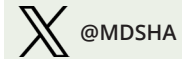
